shall be carried out unless that will is in conformity with law. The enquiry must then be; what is the law ? Municipal corporations exist at the will of the Legislature. This will of the Legislature must be exercised under the instructions of the constitution. This fundamental law, the constitution, was the work of the majority and by this instrument the Legislature is empowered to exercise its authority over all matters of legislation, among which are municipal corporations. It would be impracticable for the courts, even had they the power, to alter this division of the wards in the city of Wilmington, marked out and laid off by the Legislature. After listening to the arguments on both

sides of the question, His Honor was of the opinion that the Act of the Legislature, ratified February 3, 1875, clearly authorized the

election under which the plaintiffs claim to recover, that this Act of the Legislature was not unconstitutional, and that the plaintiffs were therefore entitled to the control of the city government.

The defendants made a motion for an appeal, which was granted.
