Phillis Moore, colored, charged with disorderly conduct, was found guilty and ordered to pay a fine of \$50 and costs. The complaint against Phillis was of a rather serious nature, but will not bear ventilation in these colums, which accounts for the heavy penalty imposed. The same defendant, arraigned for con-

tempt, she having abused one of the witnesses and acted otherwise in a disorderly manner in Court, was ordered to be confined for thirty days in the Guard House. Nancy Ann Churchwell, charged with stealing certain clothing belonging to Delia Hill, was ordered to give bond in the sum of \$100 for her appearance at the next term of the Superior Court. Convict Shot. On Monday last four of the convicts recently arrived at the County Work House from the State Penitentiary at Raleigh effected their escape. They were at work in the brick-yard and were strongly guarded, but being desperate men they seized an opportunity and made a dash for freedom, alhough they must have been confident that one or more at least must pay the penalty with their lives or be wounded as they ran.

They were fired upon by the guard and one was known to be wounded, but they all succeeded in getting off. Yesterday, however, the wounded man, whose name was Thos. Crawford, was found dead near a branch about one mile from the Work House. He was wounded in the hand and also in the

right side, the latter having doubtless caused his death. Coroner Hewlett was notified and was to hold on inquest over the body yesterday afternoon or this morning. Another of the men who effected an escape was recaptured by Mr. Benj. Mathes on Wednesday night. Mr. Mathes had secreted himself at the Northeast bridge, and after awhile he noticed a man advancing

cautiously over the bridge. Mr. M. let him approach until he was within reach of his hand, when he rose suddenly, presented

the banister and attempted to come in; he stated that he wished her to leave his house, she would break all the things up, then he shoved her backwards to

the ground; in about one-half minute she arose and caught the banister again; he then shoved her with both hands; did not see any more until ten minutes past two; I then saw Mr. and Mrs. Flynn taking her in

the piazza. Dr. W. W. Lane called: Do not know inything about the disturbance; was called upon at two o'clock but declined to go. Maria Jane Hall testified: When I saw Mr. Flynn have Mrs. Reynolds gathered up in his arms; he tried to put her over the handrail and had her near balanced; he then tumbled her down the steps; she arose, hung on to the hand rail and cursed him; while she was cursing he replied, "thank you; I am much obliged to you;" she again attempted to go onto the piazza; he shoved her off while standing on the ground; did not see her any more until after death, about three P. M.; after death, saw her body; they turned her over; she smelt so strong of whiskey it made me sick; I never

saw Mr. Flynn strike her.

Julia Ann Martin testified: Heard a noise towards Mr. Flynn's, in the kitchen part of the house: heard him order Mrs. R. out of the house; after that she attempted to enter; he then caught her and took her to the banister; he could not pitch her over the banister, but drawed her, and shoved her down the steps; then she cursed him for a black-eyed son of a b-ch; he thanked her for it kindly; he told her it was his house and he was going to rule his house; to go out and ge home, he did not want her there no how; then she arose the second time to go in any how, then he pushed her back. Henry Skipper testified: The first I saw he had her up going to throw her over the railing, but did not do it; then she swung around the post, and he pushed her off the steps; then she arose and held on to the banister; then he told her to leave his house, he did not want her to come in there; then she attempted to enter again, when he


