A Home Fertilizer-Excursion to the Brunswick Pits,

We have so often dwelt upon the advanages which would accure to our people from the full development of the resources with which Nature has in such matchless profusion blessed our State, that we sometimes fear our monitions may seem stale to our readers, and binder rather than advance the cause we have at heart. Yet, in our capacity as a public journal and exponent of the true interests of the people to and for whom we speak, we deem it our duty, upon every occasion that presents, to reiterate and insist upon that truth the proper appreciation and appropriation of which we believe of more importance to material growth than any other which could be mentioned: that is to say, that within our own borders and at our very door is stored every element and substance necessary to our prosperity as individuals or as a people, and that we only need a little confidence in our own ability and in each other in order to see that fact demonstrated.

We were moved to speak of this subject at present by what we observed yesterday as one of a party who visited, by special train of the Carolina Central Railway, a tract of land 17 miles from Wilmington on the line of that road, belonging to Messrs. Cronly & Morris, of this city. The party consisted of Mr. Roberts, the President of the road, Superintendent Fremont, and a number of gentlemen interested in the road and in agricultural pursuits, and the object was to make a thorough examination of the locality with reference to the extent and quality of the marl deposits there, and the feasibility of getting the marl to the rail-

road at a reasonable expense A number of places on the tract, remote from each other, were visited, and from the indications of the outcrop we were satisfied that a very large portion of the whole is underlaid by a bed of "blackrock" marl and a white shell marl of yet undetermined extent, the whole being from 6 to 12 feet in thickness. The so-called bla rock has about it nothing of the nature of rock-being soft and friable-and on exposure to the air it exchanges its blueishblack color for a grayish-white; owing to the evaporation of its water. The proprietors having sent a sample to the Department of Agriculture, at Washington, an analysis was ordered with the result set forth in the following letter to the Com-

LABORATORY OF DEP'T OF AGRICULTURE, ) WASHINGTON, D. C., June 29. Hon. Horace Capron, Commissioner:

SIR-I have the honor to report the following analysis of a deposit found 17 miles from Wilmington, N. C., upon the borders of Livingston Creek, Brunswick county. The substance examined was nodular in form, possessing a structure somewhat like tufa, many pieces being tubular with shells adhering upon the inner surface, and evi-dently having had an organic vegetable core; grayish-white in color, of small spe-cific gravity, and to be considered as concretions. A single lump of a different na-ture accompanied these specimens, which possesses most of the characseristics of the "South Carolina phosphatic deposits," espe-cially in being richer in phosphate of time than the first-mentioned samples. It would be interesting to know if the large mass was obtained from the same formation and

locality as the smaller nodules. The latter yielded, in 100 parts: Water..... 0.200 Silica (fragments of fine hyaline Carbonate of Magnesia..... 5.018 Phosphate of Lime...... 8.470 Alumina and Peroxide of Iron. 2.332

The very high percentage of Carbonate of Lime in this material suggests its use as a fertilizer. The smaller proportion of Phosphate of Lime adds greatly to its value and places it higher in the list of Lime Marls than the average of specimens exam-

ined in this laboratory. Very respectfully,

THOMAS AUTISELL, M. D., From a very close inspection of the beds ve are inclined to believe that they will not throughout their entire thickness maintain an equal proportion of the salts of lime; but experience on the growing crops, with frequent analyses, will soon enable the marl to be so taken from the beds as to secure a definite composition of high agricultural value. The sooner to make this desirable determination and at the same time bring the subject to the consideration of the agricultural fraternity, it has been determined to make preparations to ship a car-load to each of several principal stations for gratuitous distribution in time for the spring crops, and the railroad company will so reduce the freight as to enable those who wish to make more extended experiments to supply themselves, on the line of the road, within 100 miles of the pits, at a uniform price of \$5 00 a ton, freight paid. For greater distances a small advance will

We believe that when the farmers become accistomed to the use of marl and appreciate its value, that it will not only secure the profitable working of these pits, but of many others in localities scattered all over the State which are now unknown or unthought of, and with a resulting economy in the first cost of fertilizers and in increased returns for labor expended which will be of almost incalculable value to our producers.

BRUIN.

Big Bear Hont In Pender County. On Tuesday last about dark the attention of Mr. Thomas J. Lee, of Holly Township Pender County, was called to the squealing of a hog. Feeling that a bear had seized one of his swine, he at once summoned several of his neighbors. Armed with their double-barrel shot guns and provided with dogs the party, comprising some of the

best huntsman of the vicinity started forth to bring bruin to judgment. This was on Wednesday morning a little before daylight. Pretty soon Mr. Lee discovered an old female bear and three cubs. He took deliberate aim at a distance of seventy odd yards, fired and brought the mother to the ground. In a few moments she arose and walked rapidly toward the marksman. He then gave her the benefit of the contents of the other barrel, which again stunned her. Soon, however, she was up and heat a retreat to cover in good though rapid order. Seeing the old bear had received a mortal wound, Mr. Lee turned his attention to the cubs, and drove two of them up a tree. Here he was joined by Mr. J. M. Lee.

Two of the cubs were despatched by five Joined by Messrs. Moore, Beasley and Sears and several dogs, pursuit was made of the bruin mother, whose severe wounds had prevented her from going very far. Mr. Beasley attempted to shoot, but the cap failed to explode. The bear turned savagely upon him and would no doubt have soon enfolded him, but a well-directed shot brought the ferocious beast to the earth, dead.

The trail of the third cub was soon after found, chase given and the animal treed. Three shots put an end to its life; and thus closed a bear hunt that occupied in all about two hours, and resulted in the death of three of the wild animals which have greatly annoyed the farmers of Holly
