THE ROBESON CASE.

The proceedings at Greensboro are preliminary. If Judge Dick issues a mandamus commanding the Commissioners to return McNeill and Norment as elected, we presume an appeal to the full Bench will be taken instantly by the counsel of Sinclair and McEachin. We agree with a writer in the Raleigh News that a Judge of the Supreme Court has no authority to issue a mandamus. Was that not settled in the ease of Brown vs. Turner? The writer alluded to asks: "If a Radical "judge can issue a mandamus com-" manding the County Commissioners "ers of Robeson to grant certificates to " Norment and McNeill, why may not "Democratic judges issue a manda-" mus requiring the commissioners of "Wake and other Radical counties " to grant certificates to the defeated " Democratic candidates?"

This of course would produce confusion worse confounded. Two sets of candidates would stand and clamor for admittance. The News' correspondent says: "To obviate such an absurd-"ity, lenislative bodies always judge " of the election of their own members. "Courts have no control in such mat-"ters. There is neither precedent "nor law for it."

This correspondent then gives his inference from the scheme of the Radicals: "By law, the Convention "is to be organized by a Justice of "the Supreme Court, or if none at-"tend, by the Secretary of State. "The Secretary of State, Mr. Hower-"ton, is understood to take this posi-"tion,-and if we err we will cheer-"fully make the correction."

"We understand Mr. Howerton's "position to be that if he has to swear "in the Convention, and the defeated "Radical candidates from Robeson "county present themselves with cer-"tificates, no matter how or when "obthined, 'he will be damned' if he "swears in the Conservative members "elect who hold the certificates regu-"larly given at the proper time by the "proper officers."

This may be the bold and revolutionary course which the Radicals wish to pursue, but we must say that we give them credit for just a little too much sense to "try it on" in the coming month of September, in this fair year of our Lord, 1875.

ANDREW JOHNSON'S SUCCESSOR. The Hon, D. M. Key, of Chattanooga, who has been appointed by Governor Porter, of Tennessee, to succeed ex-President Johnson in the United States Senate, is at present one of the chancellors of the State, bus has not figured much in Tennessee politics. Southerland as lessee, he has taken into consideration the fact that the route at present followed by the road, around the "great square," is one offering very unequal facilities to citizens living, respectively, north and south of Market

The Street Hallroad.

This route is one traversing only a limited section of the city, whether considered in its extent from north to south or from east to west-indeed, from the small extent of territory in which the main line is contained, the conceit has sometimes floated through our head that the whole affair might not inaptly be called a "pocket railroad." And yet it is not a short railroad for a great deal of material was used in its construction-only too much best upon itself to meet the public taste. It is a comfortable enough road, too, smooth and well-stocked, and recently the rate of fare has been fixed at a popular price, a matter of the first necessity in the conduct of a successful street railroad. But somehow it has long been felt by a majority of citizens, without their being conscious of any particular reason for the feeling, perhaps, that the street cars would answer very well as a convenience for a very hot or rainy day, but at other times were not of especial service to any one not living directly on the line-

rather to be avoided, indeed-and in no

sense to be regarded as a necessity in the

daily life of the city. We think we can give a lucid expression to the reason lying back of this state of public feeling by simply remarking, as Commodore Vanderbilt, we think, remarked of some wild-cat road a while ago-" It cannot succeed because it leads from nowhere to nowhere." Business men do not use it, because it will not earry them from the neighborhood of their place of business to others at a distance. Strangers do not use it, because they learn that riding over it will not give them so fair a view of any part of the city as can be had in a few short walks. People out visiting seldom use it. because they can go from place to place, often, by shorter routes and in less time than "around the block." Church-goers do not use it so much as they would if it was run with reference to the hours of service. Families do not use it for exercise or when it is not convenient to have a carriage, because it takes them only through a few familiar streets in the part of the city near their own houses-so that they come back

scarcely feeling they have been away. Now, we believe that a straight road traversing the city from end to end or from side to side would draw passengers of every class we have mentioned from the parallel and intersecting streets for a long distance on each side of the road, and grow to be a public necessity; and we learn that it is something very like this which Mr. Southerland and the new Company have now de-

termined to give us. It is intended to commence work early this week in tearing up the track on Seventh street and upper part of Market, and to relay the same (probably on Fourth street, thought that is not yet determined, from Market to Castle and up Castle to Seventh. Work is now progressing to fit the rolling stock on that route for a straight rather

than a circular track. Personally, the writer believes that the most profitable routes which could be run in the city would be one extending along streets near the waterfront, from the Cotton Press or Central Depot to the Cotton Mills, and another directly out Market street. The building of the former would be attended with some difficulties at the crossing of the Weldon Railroad, but we think a trestle and bridge would pass it and we expect some day to see it built. When the road is extended to the sea-side doubtless the need of a central cross-town road will then be also supplied. Doubtless at some time, also, a second track parallel with the river will have to be laid on Seventh or some adjacent street. We throw out these suggestions only as pointing to the future, and wish to them to be so understood. The management of the road, of course, have far better facilities than we for arriving a correct judgment of the pres-ent necessities and opportunities of the case, in the light of facts as they exist.

The Turnpike Company.

We learn that the Coast Turnpike Company have finally settled the matter of the building of their road, so that the matter is no longer an open question whether or no we are to have a first-class boulevard from this city to the sea shore. The road is to be built. It now only remains to let the contracts, and we understand that some action looking in that direction would have been had yesterday but for the absence of certain parties in interest from the city. We hope to be able to give some definite information in our next in reference to the practical commencement of this long-desired improvement.

Brunswick Superior Court. The Superior Court for Brunswick county commences at Smithville to-morrow, His Honor, Judge A. A. McKoy, presiding. The first cases to be tried, we learn, are two important ones from this city, and a large number of witnesses are to go down from this city to-day and Monday.

Stealing a Trunk of Clothing. &c. Henry Woodward, colored, was arrested by Officer Strode, yesterday, charged with stealing a trunk, containing clothing, &c., the property of Nancy Faison. It appears that Woodward entered the residence of the woman, on Third, between Campbell and Hanover streets, Friday night, while she and ber children were absent, and carried the trunk off. The clothing and other articles in the trunk are estimated to have been worth from \$25 to \$30. The warrant for the arrest of Woodward was issued by W. H. Moore, J. P., before whom he will have a hearing on Tuesday.

Corn, Charcoal, Sulphur, Noah's Ark,

We examined yesterday two stalks of corn which were grown in one hill on the Poplar Spring Branch Plantation, owned by Nathan Phails (our charcoal friend). It weighs 20 pounds, measures eleven and twelve feet, respectively, and evidently shows Nathan to be as good a farmer as he was a soldier in Captain Jack Hewlett's uniformed Sound company previous to the late unpleasantness. Who can beat this production, and where can a better growth be obtained on soil of the same fertility? This same truck and charcoal farm contains a celebrated sulphur spring, highly recommended by physicians, and is almost at our own doors, being about four miles from the city and in view of the ocean. Besides this, from deposits found in the soil, its owner is inclined to the opinion that it was at that point that Noah and all persons, beasts, fowls of the air and four-footed things landed from the Ark after the flood.

Capture of an Escaped Prisoner. A colored man by the name of George Thompson, who escaped from the County Work House two years ago, where he was confined under sentence for twelve months on the charge of larceny, was re-captured on Friday afternoon by Special Deputy C. H. Strode. It appears that Officer Strode got a glimpse of the fellow the day before and gave chase to him, but failed to effect his capture. On Friday afternoon, however, he was more lucky, having discovered Thompson in the woods, in company with two other colored men, engaged in playing cards. Thompson again attempted to escape by running, but was finally overhauled and captured at a point between Smith's Creek and Union Depot, when he was taken to jail and locked up until he could be transferred to his old quarters.

Thompson says that his companions in card playing were Penitentiary "birds," and are probably of the party that escaped from the Work House, where they were held under contract, at the time the prisoner Tom. Crawford was shot and killed by the guard some weeks since.

We learn by the steamer D. Murchison, that the river had fallen about five feet at Fayetteville when the boat left there Priday morning, and that there were no indications of a freshet from above. We regret to learn, however, from this statement, that the crops on the river have suffered more than has been supposed. He says that about one-half of the lowlands in which corn was planted were covered with water, which in most cases was up to the ears on the stalks. Part of the corn so submerged, which was planted late in the season, he says will be killed entirely and the remainder badly injured. The long continuance of the freshet, backed up as it was by the high water below, followed by the hot sun, must of course have been more or less disastrous in its results. In this connection we would state that on an average estimate the crop in the immediate vicinity will be cut short about one-fourth to one-third the usual vield, which will still leave a fair margin for an average crop, taking into consideration the fact that there asbeen more planted this year than usual.
