If they get 92 cents in silver they get more than they bargained for, as greenbacks was to redeem their bonds, or by the law of 1869, silver or gold. If they get less than a dollar it is owing to the law of 1873, by which it was depreciated and demoralized. Will twenty nickel pieces fetch on Wall Street to-day one dollar in gold? Not a bit of it. So away with the nonsense about depreciated currency and dishonest dealing with the bondholders. Such talk will not bamboozle anybody but simpletons or ignoramuses. It is the thinnest sort of gammon, although akin to the sublimity of effrontery and impudence.
