Seales has offered a reward of \$400 for the arrest of Charles L. Heitman, of Lexington, who is charged with embezzlement. — Winston Republican: Mr. C. C. Stoltz, of Bethania township, had the misfortune to lose a barn of tobacco by fire on the 28th inst. The building was new and the entire loss is placed at \$800. — Salisbury Watchman: Mrs. Lucy Ludwick, an aged lady living in Litcher township, lost her dwelling and all its contents last Sunday afternoon, while she and her daughter, the only occupants of the place, were visiting a sick neighbor. — Durham Plant: The town council for the town of Durham have employed Mr. Arthur Winslow to take charge of the grading of the streets and fixing the proper grades for the sidewalks, and providing a sewer system and the water mains of the town. — Charlotte Chronicle: The most encouraging reports still continue to come in as to the growth of tobacco in Mecklenburg county. It must be remembered that this is the first attempt to raise anything like a crop in this county, and the success has thus far attended the effort should be very encouraging to our farmers. — Charlotte Observer: Gen. R. D. His mind is affected. — Raleigh News-Observer: Henderson has a handsome new Episcopal church. — During September sixty discharges of licenses were issued from the State Treasury. — At Franklinton, a few days past, memorial services were held in honor of the late Rev. Moses A. Hopkins, colored minister to Liberia. The colored people conducted these exercises. They will erect a monument to the memory of the late minister. — Not long ago some persons at Warren Plains threw stones at an excursion train on the Raleigh & Gaston railroad, and smashed a window. Two negroes were captured, convicted of the offence and sentenced by Judge Gudgeon to the penitentiary. A man who changed the inspector's marks on the ends of railway ties was also convicted of that offence and properly punished. — Attempts are being made to organize a military company at Hendersonville. That at Waynesville is the only one west of the Blue Ridge. — The election by the faculty of the University of Prof. E. A. Alderman, of the Goldsboro Graded School, as "University Day Orator," is a graceful, deserved compliment. — SPARTA, N. C., Sept. 27.—I give you the Democrat as the best of the papers. Thirty-fifth District, W. C. Fields; House of Representatives, Alleghany county, R. A. Dougherty; Ashe county, John Baker. — CHARLES HILL, Sept. 30.—President Shepherd left us today to begin the exercises of Charleston College. All regret his departure. His family will remain until November 1st. — Rev. Wm. M. Clarke, of Amherst Court House, Va., has accepted

the call of the Episcopalians to take charge of this parish, and will enter on his duties the first Sunday in November. — Last year was the first when the \$30,000 pension appropriation made by the last Legislature was disbursed. There were paid last year 3,084 pensions. This year, which began September 1st, there have been 307 new applications for pensions, of which 157 have been allowed. This number added to the number paid in 1885 makes a total of 2,161. From this must be deducted 86, who have died or been dropped from the rolls.

Proceedings of the Regular Monthly Meeting—Election. Ordered on the Railroad Subscription Question. The Board met yesterday at the Court House. Present, H. A. Bagg, Esq., Chairman, and Commissioners Roger Moore, E. L. Pearce, B. G. Worth and Wm. Oalder. Proceedings of the last regular and special meetings were read and approved. Monthly reports of Treasurer and Register were submitted and approved. The general fund shows a balance on hand of \$15,205.14; educational fund \$12,811.15. Total \$28,016.29. The receipts for fees from marriage licenses were \$15.20. The Chairman reported back taxes collected amounting to \$280.68. Also receipts from sale of brick from old jail, 20,000 at \$80. The Clerk of the Superior Court reported as paid to the Treasurer, \$25 received from the Fore & Foster Planing Mill and Sash and Blind Co. Application of R. J. Jones, Chairman of Building Committee of Cape Fear Lodge No. 3, I. O. O. F., for permission to connect sewer pipe with the sewer running through the Court House yard was granted. Ordered that the valuation of property of P. Donlan, block 103, be reduced from \$1,600 to \$1,200. Also, property of Dr. E. C. Miller, block 103, from \$1,800 to \$800. Also, property of W. E. Springer, south Second street from \$8,500 to \$2,500. Jurors were drawn for the next term of the Criminal Court. The Wilmington, Onslow & East Carolina Railroad matter came up, and it was ordered that in answer to the petition presented to the Board, an election will be held on the fourth Thursday of March, 1887, at the usual polling places in the county, for the purpose of determining whether or not a subscription of \$100,000 shall be made by the county. Thirty days notice of the time and place of holding the said election shall be given by publication, and the returns thereof shall be made and the results declared and certified as prescribed by law in other elections. Registrars and judges of election for the proper conduct of the said election will be hereafter appointed, according to law.

BOARD OF ALDERMEN. Proceedings of Regular Monthly Meeting. The Board of Aldermen met in regular session last night at the City Hall. Present, Mayor Hall and Aldermen Bear, Boney, Wurt, Dudley, Doscher, Howe and McEachern. Committee on Streets and Wharves reported on the petition for improvement of Front and Second streets between Dawson and Kidder, and also on petition for improvement of Seventeenth street from Market to Bellevue Cemetery, that the market and street force could not be spared from other work, but as soon as possible these places would receive attention. In the matter of sewer from Jacobs' spring, a letter was read from Mr. Chase, estimating the cost of necessary improvements at \$4,500, and recommending that the work be done. The matter was referred back to the Committee on Streets and Wharves, with instructions to confer with the Board of Audit and Finance as to the cost of the work, and report at the next meeting with plans for the improvement. Alderman Boney from the Market Committee, made a verbal report as to the renting of market stalls, &c. Further time was asked by the committee on Streets and Wharves in regard to the matter of appointing a city engineer. Alderman Bear submitted the following, which was adopted: Resolved, That E. G. Worth, Jas. H. Chadbourne, B. P. Hall, Roger Moore and W. L. DeRoset be appointed a commission, as contemplated in the act of Assembly authorizing a subscription to the stock or purchase of bonds of the Cape Fear & Yadkin Valley Railroad Company by the city. Resolved, That the action of the commission thus appointed shall be of no binding force upon the city until the Board of Aldermen, the Board of Audit and Finance concurring, shall have ratified the same. A number of petitions for permission to erect sheds and buildings were granted—to Worth & Worth, H. M. Emerson, W. C. Williams, A. C. Wessel, and Holmes & Fillyaw. Applications of J. A. Springer and D. O'Connor were referred to the Fire Commission. Application of G. J. Boney to erect a brick metal roof building on Nutt street, for a grist mill, was accompanied by a protest from property holders in the vicinity. The application of Mr. Boney was granted. Phoenix Hose Reel Company were granted the use of the City Hall for a festival on the 18th inst. Petition of Cape Fear Fire Engine Company for a new fire engine was referred to the Fire Committee, to ascertain the cost of a new engine and report at next meeting. Chain Up the Dog. Three dogs met with sudden death in Front street market house yesterday. It is supposed they were poisoned. Several dead cats were seen in and about the place Sunday, also. The dogs were tax-paid Sunday, and beyond a propensity for loafing were "otherwise considered respectable."
