A Thriving Town. A correspondent writing from Rowland, N. C., says that on the first day of last January there was only one house in the place and now the town is incorporated for one mile square with over fifty buildings within its limits, including residences, store houses, machine, blacksmith and wool shops, a steam saw and grist mill, a steam cotton gin, and by the middle of November a cotton seed oil mill will be in operation. It is the present terminus of the Wilson & Florence Railroad, being twenty-eight miles from the junction on the Wilmington, Columbia & Augusta road at Great Pee Dee, and is in the very midst of the Alfordville, Ashpole and Cotton Valley sections of North Carolina and Carmichael and Hillsboro townships of South Carolina, whose lands are celebrated for being the best cotton producing lands east of the Mississippi Valley.

Two of the piers for the bridge over Broad river are nearly finished, and the graders on the road near Chester, S. C., are working day and night. The Abbeville Press and Banner says a contract has been made for getting out 50,000 cross ties to be used on the western extension of the road, and delivery of these ties will be made in a few days.

Poor Little Birds. Two pretty covies of partridges were exposed for sale at Front Street Market yesterday. There were four old birds and about two dozen young ones in the lot. Some of them were very small and not fully fledged, and were evidently not long out of the nest. It seems a pity to trap such small fry, and if they have not already "gone to pot" some noble sportsman might buy the lot and give them another chance to live and grow until they are fit to trap or shoot.

Cotton and Naval Stores for England. The British steamship Roseville cleared for Liverpool yesterday with a cargo of 4,600 bales of cotton, shipped by Messrs. Alex. Sprunt & Son and Williams & Murchison, weighing 2,277,681 pounds, and valued at \$223,304. German barque Burgermeister Kerstin cleared for Liverpool, with cargo of 3,350 barrels rosin, weighing 1,094,385 pounds and valued at \$3,712,25, shipped by Messrs. Williams & Murchison.

Cotton Rainfall Statistics. The region yesterday was confined to the Mississippi Valley district. The mean minimum temperature ranged from 46 degrees at Little Rock to 62 at Montgomery. In this district Weldon and Lumberton reported the minimum at 44 degrees, Newbern and Goldsboro 46, Raleigh and Cheraw 48, Wadesboro and Charlotte 50, and Florence and Wilmington, 52.

RIVER AND MARINE. Good boating water is reported in the Cape Fear and Black rivers. Spanish steamship San Juan, hence, arrived at Liverpool Oct. 29. So far fourteen foreign steamships have arrived at this port this season. Schooner R. S. Graham is discharging a cargo of railroad iron at the wharves of the C. F. & Y. V. Railroad on the west side of the river.

The British steamship Wineshoe, which arrived yesterday, has gone into dock at the Wilmington Compress, where she will take in a cargo of cotton. The steamer Cape Fear from Fayetteville, got in late yesterday morning, with flat in tow and a large freight of naval stores and cotton. She left on the return trip about 8 o'clock last night.
