J. S. Potter Charges That Squire Bornemann Criminally Extorted Money.

out a warrant Justice Bornemann. charging him with criminally and maliciously extorting from him \$2.10 by threats to imprison him and put him in the workhouse unless he paid the amount named, and refused to allow him to give bond until trial.

The warrant was served on Justice Bornemann by Deputy Sheriff J. P Flynn yesterday afternoon. He went before Justice Fowler and made an affidavit that he could not get justice in that court and it was moved to 'Squire McGowan's court. The trial will be held at 10 A. M., Monday and Justice Bunting will sit with Justice McGowan
