COTTON MILL MEN
IN SECRET CONFERENCE.

For the Purpose of Discussing the Situation and Taking Some Concerted Action.— Outlook Not Encouraging.

CHARLOTTE, N. C., Sept. 7.—Hosiery yarn manufacturers, representing 288,000 of the 400,000 spindles engaged in that line of goods in the South, held what was said to be an important secret conference here today. They held two sessions, lasting the greater part of the day, and after the first one was given out that there was nothing to be done in the proceedings, which several resolutions had been passed and the situation discussed, but a meeting for the public in the afternoon, held about the meeting closed, but no men in attendance. One of the resolutions looked to the fixing of the price of hosiery, and another to the case of yarn. Samuel A. Carter, of Atlanta, was chosen chairman, and J. F. Taylor, of Winston, S. C., secretary. The principal feature of the meeting to those on the outside is the presence of those concerned, which is quite unusual. Mr. Taylor, the secretary, said the meeting was entirely confidential and had no connection whatsoever with any organization. It was called by six or eight prominent spinners, who along with many others realized the necessity of concerted action to take up the situation. The meeting, said Mr. Taylor, was for the purpose of discussing the situation and getting on a better footing as to the future of the industry. It was favorable, if the present cotton crop can be kept out of the hands of the speculators. If the crop should prove to be more than 11,000,000 bales, they believe the speculation will hardly be able to manipulate it. One of the most prominent men attending the meeting is E. S. Reinhardt, of Winston, N. C., president of the American Cotton Manufacturers Association. Mr. Reinhardt does not see anything particularly encouraging in the outlook, and does not see that there is to be done to bring about a benefit. "Yarns continue to sell at low prices," he said, "and cotton fails to decline, despite the fact that the season for lower prices will soon begin to come in. This is the price decline when the crop begins to come in." "I thought to, but it doesn't," replied Mr. Reinhardt. From interviews with various spinners who are attending the meeting, the reporter learned that the curtailment of production since May will aggregate 25 per cent. of the Southern spindles running on hosiery yarns.

LEAVING MUKDEN.

The Main Army Reported Pushing Northward in the Direction of Harbin.

JAPANESE STILL PURSUING.

No News from Port Arthur.—The Critical Stage for Kuropatkin Believed to Have Passed—Japs Captured Stores, Etc., at Liao Yang. By Cable to the Morning Star. There is no news from the Far East, either from Russian or Japanese sources. For the world watchers of the great tragedy the curtain has been dropped, and all is conjecture. Not even an expression of opinion comes from Japanese sources, but from St. Petersburg it is indicated that the authorities are confident the critical stage for the Russian retreat is passed and that Kuropatkin is no longer in danger of losing any part of his forces to the pursuing Japanese. The Russian commander has arrived at Mukden and it is given out in St. Petersburg that the bulk of his army is now near there, while a dispatch from Mukden says the main Russian army is pushing northward and recapturing that place. It is indicated that the Japanese are still harassing the Russian rear. Farther than this nothing is known. An absolute news silence prevails. The Battle of Liao Yang. TOKYO, Sept. 7, 8 P. M.—The general staff has not yet made public any details of the battle of Liao Yang. The people are still celebrating the victory, but there is considerable speculation about the details of the battle. General Kuroki's movements since Sunday. It is reported that the Japanese, notwithstanding the ravages of the war, captured several hundred tons of Russian stores and ammunition at Liao Yang. The report that Lieut. Terauchi, son of Lieut. Gen. Terauchi, minister of war, was killed in fighting before Liao Yang is denied today. Battle Going On. PARIS, Sept. 6.—The St. Petersburg correspondent of the Echo de Paris says: A great battle is going on before Mukden. The First and Second Japanese corps are engaged against General Kuroki. General Kuropatkin with the bulk of his troops is moving toward Tieling. Russians Evacuating Mukden. MUKDEN, Sept. 6.—(Delayed in transmission.)—Part of the Russian army which is coming to Mukden by way of the coast is being cut off. All day and night Monday the Japanese on the hills on the east road shelled the Russian troops. In one instance the Japanese infantry attacked the Russian position on the hill and artillery which had taken to the hills, running parallel to the Japanese, in protecting the flank of the retreating army. Troops, guns and transport are pouring into Mukden by train and road. Considerable transport was left behind. The road is in a frightful state, owing to the heavy rains Monday. The main Russian army pushing northward is evacuating Mukden. Army Near Mukden. ST. PETERSBURG, Sept. 7, 5:35 P. M. The bulk of the Russian Manchurian army is near Mukden, where it now appears General Kuropatkin is under-standable. COSTLY GEM LOST.

Mrs. Pembroke Jones Met With a Misfortune at Mrs. Hermann Oelrichs' White Ball, New York.

New York, Sept. 7.—A special dispatch from New York says: "A sensational echo of the 'white ball' given by Mrs. Hermann Oelrichs last month came last night, when it was reported that a valuable jewel was lost there. The affair has been kept secret, but friends of Mrs. Oelrichs divulged it by consulting detectives. "It was Mrs. Pembroke Jones who lost the jewel—a diamond from a magnificent lace pin, and reported to be valued at \$800,000. The exact value of the missing diamond is not disclosed, but it is said to be one of the largest on the continent. It was carried by Mrs. Jones until after the cotillion, which was held by Harry Lehr and Mrs. W. K. Vanderbilt, Jr. Mrs. Jones quickly looked about the ball room and with her husband searched each spot she remembered having been in, but the diamond was nowhere to be found. Mrs. Jones contacted the secret to Mrs. Oelrichs. Finally a number of the guests learned of the loss and the searching became general. In the morning every place was thoroughly searched in vain. "The diamond is now among those which Mr. J. Stewart Barney, Mrs. Willie E. Carter, Mrs. John B. Drexl and others lost here recently. "Mrs. Jones has said little or nothing about the missing gem. She has had the gown she wore at the ball altered and has yet refused to be interviewed to give the slightest clue to the whereabouts of the magnificent diamond. "The necklace was considered one of the handsomest worn at the ball, and so far as can be learned, it was worn there for the first time. According to report, a fac-simile of the necklace was ordered by Mrs. Jones, on exhibition at the St. Louis Fair."

NEGRO LYNCHED BY
A FRENZIED MOB.

WAS CHARGED WITH MURDER.

Mob Estimated at Over 1,000—Held the Fire Department at Bay With Guns. Militia Ordered Out, But Were Powerless—Confession.

BIRMINGHAM, ALA., Sept. 7.—Acting Governor O'Connell has ordered a company of soldiers to Huntsville to protect the negro Maples, who was arrested today, charged with the murder of John Waldrop, an old peddler. Since the arrest of the negro there has been a feeling of unrest among the people of Huntsville, and open talk of lynching has been heard in many violent threats being made against the prisoner. Governor O'Connell has given orders that the negro's life be protected and no mob violence allowed. It is believed that the object of the crime was to get the body of the old peddler was found near the road with his pockets rifled, \$300 having been taken from him. "It is believed that the negro was arrested to-day and at the time was spending money freely. It is asserted that blood stains were found on his clothes. "HUNTSVILLE, ALA., Sept. 7.—After being held at the jail for some time the prisoner, while the fire department was held at bay with guns and shot, his deputies and the soldiers, a mob estimated at over 2,000 persons, including Horace Maples, the negro accused of murdering John Waldrop, by striding him to a tree on the court house lawn. "The mob began to assemble this afternoon and to-night. The sheriff and his deputies pluckily stood their guard, but they were powerless before the mob and the fire. The local military force was called out, but they were outwitted by the men who conceived the idea of smoking out the prisoner. "At 12:05 o'clock the jail was freed in the back part, burning fiercely, and a dense smoke spreading through the upper stories and cells of the building. "The mob then approached within block of the scene and was driven away with bullets. The crowd on the outside would allow nobody to enter the jail, and the prisoners were forced to surrender to the crowd. The sheriff and his guards would not give in, but in some places the negro got through a window and jumped from the building into the crowd. He was chased down and a rope thrown around his neck and he was pulled up to the court house lawn. "There was an immense crowd on the lawn. While Maples was confessing his crime and implicating a number of the mob, two negroes, John E. Wallace, Jr., and Solicitor Earl Pettus delivered impassioned addresses trying to dissuade the mob. They were booed down, but finally when Solicitor Pettus called on all who were in favor of the law taking its course to hold up their hands, about half in the crowd did so.
