The Revenue Act. The following is a carefully prepared synopsis of the Act to raise Revenue, recently adopted by the Legislature and arranged by Mr. Spelman, the Senate Reporter of the Sentinel, its entire provisions being brought within a convenient compass. The synopsis will be found very convenient for reference : SECTION 1. The General Assembly of North Carolina do enact, That the taxes

hereinafter designated, payable in the existing national currency, shall be assessed and collected under the rules and EDUCATIONAL. - (See School Law.)

Polls .- Each taxable poll, twentyone to fifty years old, except those exempt by County Commissioners, one dollar and five cents, the proceeds to be devoted to educational purposes prescribed by law. If any poll tax shall not be paid within sixty days after the

THE TROUBLES IN SPAIN. The Republic in Spain, from present indications, seems destined to be shortlived.
