POOL'S ADDRESS.

Now that Holden has fled like Caligula from Rome, John Pool is left head and shoulders above any other man in trenchery, bannion and bow coming.

Friendly and benevolent legislation for the south has been checked and delayed. General amnesty, large appropriations of public lands for educational and agricultural purposes, and projects for great works of internal improvements, in railroad facilities, the payment of just claims for losses during the war, and a general solicitude for our material interests, have all been prevented in view of the possibility, if not probable necessity for a further resort to arms in order to bring the recently insurgent states into harmony and safe relations with the national government.

What does this declaration on the part of your senator mean? It is simply this. He has not exerted himself to give you justice throughout the state, because he has not done so for general amnesty because it will get in the hands of Dragg and Vance as competitors with him for the United States Senate. He has not tried to get you appropriations of public lands for Congress, for building railroads and educating the people, because you are not republicans. It is John Pool, John Dewese, Frouth, Abbott, Bingham, Bowen, and like scoundrels in Congress from other states, that have retarded the prosperity of the south. As to amnesty, it has been dodged off by Holden, Dewese, Pool and Company. Any man in the state who would profess radicalism, could get his disabilities removed. Pool is an unscrupulous, a pardon peddler. His profits were not in money, but in acquittions to his party strength.

Bingham, Thad. Stevens and Horace Greeley, with the bitterest northern republicans, have been calling for amnesty these four years. Such characters as Pool, Bowen and Dewese have prevented it. We can give a case in elected to the senate by the people of Orange, Caldwell, Holden, and Judge Reade put their heads together to prevent us taking our seat. We offered the same certificate of election that other senators did and offered to take the same oath, but we were not allowed to do so. We had a slight personal acquaintance with Hon. John Corode, of Pennsylvania, one of the extreme radicals from that state. In less than an hour after we reached Washington, Corode had our name on a bill with a list of some 200, for pardon. A majority of the reconstruction committee, including Thad. Stevens, Bingham and Farnsworth, voted for it. We stated to them simply that we had been in the Confederate army and congress, and had been recently elected to the state senate. Bingham said he would vote to remove our disabilities, not caring what we had done, and he would vote to remove the disabilities of any man in North Carolina.

Hon. Marvin, a republican member from Saratoga, approached old Thad on the subject of the removal of our disabilities. Thad. voted for it as readily as Mr. Bingham. Boutwell, from Massachusetts, now secretary of the treasury, was the only member of the committee who was opposed to it. He said he would vote to remove our disabilities, but he had not favored the reconstruction measures in other ways, he would not vote to remove the disabilities of any but republicans. Congress has adhered strictly to the Boutwell policy, except in a few cases. Pool, Abbott, Heaton, Dewese and the entire congressional delegation from North Carolina besieged the reconstruction committee and had our name taken from the bill. Even old Mr. Boyden, who calls us "help and unhelpful," put his influence on that side, though he volunteered to tell us he had a bill for the removal of our disabilities. We caught the old man looking one way and rowing the other, pretending to favor and yet opposed to the removal of disabilities. Since then, we have thought the old man more "unhelpful" than "help," and more hypocritical than true.

The most remarkable omission in Senator Pool's address, is his failure to mention Mr. Bagger's charge, made upon him under the solemnities of an oath, that he (Pool) had proposed to place certain citizens of North Carolina in the hands of a desperate pirate in his personal acquaintance, and have them lost, or murdered, as Gov. Clayton of Arkansas had done. Why did not the black-hearted scoundrel, defend or justify the infamous charges made upon him by a leading member of his own party? Oh, baseness, if thou wert not already named, we'd call thee "Pool," with the surname "John."
