NEWS BY THE MAILS.

WASHINGTON, Dec. 15.—The disarming of the black troops in Mississippi arises, probably, from the fear of trouble, now that the holidays are so rapidly approaching. It is a fact that women and children are now in the Northern States, whose homes are in the South, but prefer to remain where they are until the dreaded Christmas time has passed.

The fears of trouble are stronger in Mississippi than in any other State, though in certain portions of Alabama serious misgivings exist. When Gen. Canby mustered out the blacks in Louisiana recently, he ordered them all to be disarmed, and this action, I am informed, was based almost solely on the fear that a collision might occur, should the negroes be permitted to retain their arms.

What Gov. Humphreys has done in Mississippi, is no more than Gen. Canby has done, though in the one case it was by Government action and in the other by the State.

There is no session of Congress to-day, both Houses having adjourned yesterday until Monday. WASHINGTON, Dec. 15.—The departure for Europe on Wednesday of the chief secretary of the French Legation is connected with the details of the Mexican question, and growing popular sympathy with the Liberal cause in Mexico, together with the appointment of General Logan, has led to a communication between Count Montheville and the State Department, which resulted in sending a message to the French Emperor for definite instructions.

It is said the withdrawal of the French legation from Washington will take place in case of the formal appointment of an United States Minister to the Mexican Republic.

WASHINGTON, Dec. 15, 1865.—The two thirty-vote in the House yesterday, adopted the original Stevens resolution; is regarded as settling the question of admitting Southern claimants for seats. They will not get in this winter. The President expressed himself this morning as disappointed by this radical vote.

Additional News by the City of Boston. The City of Boston, when fairly at sea of Queens-town, was overhauled by a British man-of-war in search of the Fenian "Head Centre" Stephens. Her officers went on board and detained the vessel for hours. Stephens was not there, but the City of Boston carried out a very active Fenian delegation to the brotherhood in America, bound, it is said, to Chicago, Buffalo and St. Louis. It was thought in Dublin that Stephens had reached France. Eng. land was worried and alarmed, and the Fenian organization was extending and becoming solidified in Ireland.

The first contradiction to the list of British blockade runners appears in the London Times of the 23rd ult. Messrs. C. W. & W. G. write to say that they were "never interested in the extent of one shilling either as owners of blockade runners or as shippers of goods to the South."

Great satisfaction is everywhere expressed that Queen Victoria will open the next session of Parliament in person. The London correspondent of the Manchester Guardian says this is a spontaneous act on the part of her Majesty, and might have happened sooner had less obstructive importunity been used in obtaining quarters.

The Bankruptcy Bill. The bill introduced into the House of Representatives, on the 11th instant, to establish a uniform system of bankruptcy throughout the United States, provides:

1. That the District Courts of the United States shall be constituted courts of bankruptcy, and that they shall have original jurisdiction in their respective districts in all matters and proceedings in bankruptcy. It also provides that the several Circuit Courts of the United States within and without the districts where the proceedings in bankruptcy shall be pending, shall have a general superintendence and jurisdiction of all cases and questions arising under this act.

2. Provision is made for the appointment of Registers in bankruptcy, to assist the Judge of the District Court in the performance of his duties under this act. The Register must be a lawyer, and must give bond to the United States. He may also be able to subscribe the oath of office approved by Congress in July, 1862. The duties of the Register in bankruptcy are clearly marked out for him, at length, in the bill.

3. An appeal may be taken from the District to the Circuit Court in all cases; but no appeal shall be allowed in any case from the District and Circuit Court unless it is claimed, and notice given thereof to the Clerk of the District Court, to be entered with the record of the proceedings, and also to the assignee or creditor, as the case may be, or to the defendant party in equity, within ten days after the decision appealed from. No appeal or writ of error shall be allowed in any case from the Circuit Courts to the Supreme Court of the United States, unless the matter in dispute in such cases shall exceed two thousand dollars.

4. The bill sets forth at length how to commence and continue proceedings under it in the courts designated. It also directs the manner of making assignments, and defines the duties of the assignee, the examination of bankrupts, and the distribution of the bankrupt's estate.

5. It provides certain penalties against bankrupts who shall, after proceedings, have been commenced, secure, destroy, or part with any part of his property, with the intent to prevent it from coming into the hands of the assignee. It also provides penalties against any officer who shall take bribes from parties interested in any
