Negro Testimony.

Remarks of R. Y. McAllen, Esq., in the House of Commons, on the 21st of February, on the motion to indefinitely postpone the bill allowing free persons of color to testify in courts of justice.

MR. SPEAKER: It was not my purpose to address the House to-day on this bill, but fearing it may be the pleasure of the House to postpone the bill and thereby preclude further discussion, I desire to state some of the reasons that will control my vote on the bill.

Recognizing this principle, the Convention from the people, which assembled but a few months since, promptly and unanimously abolished slavery in North Carolina. No one in that Convention thought slavery morally wrong.

It is urged that the people are not prepared for this great change. I can assure the gentlemen that they underestimate the intelligence and patriotism of the people; the people are ahead of their representatives.

On his own civil courts, before our own judges and juries, this Legislature will confer a boon upon the people and enter itself to the everlasting gratitude of the people.

Mr. Speaker, I am not here with the objection that the admission of negro testimony, in our courts of justice, will do more harm than good. It is not my duty to do so much harm as the admission which is the daily course before the ordinary courts.

Other States have, with almost unanimous assent, accepted cheerfully the terms of the President. It is North Carolina less loyal to the Union than her other sister States.

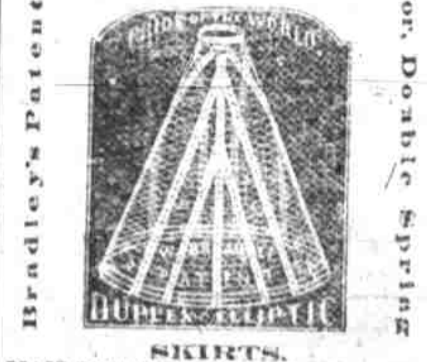
