FROM AND AFTER AUGUST 1, 1864.

Trust Deed, conveying estate to use, to be stamped as a conveyance. Warehouse Receipts. For any goods, wares, or merchandise, not otherwise provided for, deposited or stored in any public or private warehouse, not exceeding \$500 in value.

GENERAL REMARKS. Every stamp may be used indiscriminately upon any of the matters or things enumerated in Schedule B, except proprietary and playing card stamps, for which a special use has been provided.
