



Mr. Dargan moved to lay the bill on the table. Not agreed to. Yeas 30 Nays 81.

The bill then passed its second reading. On motion of Mr. Garriss, a message was sent te the Senate, proposing to proceed forthwith to the election of six councillors of State. The Senate by message announced concur rence, and the House having voted adjourned.
