THE RESULT OF IMPEACHMENT.

The Times would laugh in our face if we showed him that a single Republican Senator will vote to depose President Johnson for any other reason than to transform the policies of the Government from a neutral to a Radical regime next November. The Times proclaims the absurdity of such an assumption when it hounds on the Senate to convict for reasons other than a *de facto* outside of the articles to which the President's defense is confined before the body which has the power to remove him.

A vote to convict, cast by any Republican Senator under these circumstances and for such reasons, is just as corrupt, just as outrageous, just as monstrous a transaction as the acceptance of a bribe of one million dollars to do Mr. Johnson the obvious injustice of acquittal.

All these formalities, all these speeches, all this array of eminent counsel, all the marches of the House to the bat of the Senate, and all the session of the Civil Justice and Senators, do not cover over, nor do they seal off, the eyes of the people to the actual character of this impeachment.

The long-sought charges are true. The arguments of the Managers are true. There is no more substance of Justice in the impeachment of Grant than in the words "Wagering Washington's reputation." The impeachment is a swindle and a swindle, give up with formalities and decorated with the ingenious phrase-making of wordy lawyers; it is the first place to draw the attention of the people's attention which would otherwise be fixed on the South and the gigantic crimes enacted there; in the second place to get money enough, in conjunction with carpet-baggers and negro votes, to do the Presidential election.

Moreover, Republican Senators know that these charges are true. They know that the impeachment is a sham. They know what the managers are doing as which in impeachment means. The Times would say that we had not read its columns attentively if we had not perceived the bold defiant avowal that the President must be removed for political reasons, for "party reasons," for reasons other and different from those set forth in the articles of impeachment, for reasons insolent and treacherously declaimed about by the Managers for reasons upon which Mr. Johnson is denied a defense. Now we state again, that the Times may not again misappropriate the World's notions of political morality, that in our Judgment there is no greater crime in Senator's accepting a bribe of a million dollars to do Mr. Johnson the obvious justice of acquittal than in his accepting willingly and with conscious guilt the bribe of a share of party patronage and party power to do the country-wide and grievous wrong of conviction and removal.

Every Senator who votes to convict and remove Andrew Johnson, must in the forms of the Court vote to convict him of guilt and guilty intent precisely as charged in the article. There is not one lawyer in the Senate who can honestly vote that. He may honestly think him deserving of deposition on a thousand other grounds, but he must vote concerning his guilt on these charged grounds. It is just possible that Senators like Morgan, Sprague, and others of unstricken and untrained intelligence, may not be able to make this distinction, but no lawyer can fail to make it, now that it has been pressed upon his attention by the President's counsel, without conscious guilt. Senator Connington, for example, cannot vote to convict Mr. Johnson for guilt and guilty intent charged in the article, without knowing that he is bribed by a share in party patronage and party power to do Mr. Johnson a grievous wrong. Now the moral quality of such a vote is incomparably blacker and more degrading than the acceptance of a bribe of a million to do Mr. Johnson the justice of acquittal.

The Times threatens that it will denounce, as bribed and bought-out, any Republican Senator who does not vote concientiously for Mr. Johnson's acquittal on the guilt and guilty intent charged and stone to be voted upon. Its columns have long been surrendered to that sort of unscrupulous terpety. But the Times may yet learn what its opponents have already discovered, that the price it pays for that indulgence is impotence to convince or stir the public mind.

If convicted or acquitted were a matter of money, then whiskey thieves, who may more to put Johnson out and Wade in than any other set of men can possibly afford to pay for the reverse. Johnson is the enemy of the whiskey-thieves. His removal has diminished their gains, as the records show. Wade is the friend of the whiskey-thieves. His Presidency will give them full swing. But we have never believed, and we do not now believe, that Johnson will be convicted.

First, because no Republican Senator can vote to convict without conscious dishonesty and violation of his sworn oath. And we believe that there are honest Republicans in the Senate chamber. They, too, are likely enough to be reinforced by Senators who, even if not honest, will not care to be pronounced dishonest, will not let partisan judges by all the legal profession of the United States, by a majority of the individual men in every calling, and by history be at all to come.

Second, because it is a party blunder, though not obviously one, to remove the impeached President; a blunder second only to the blunder of impeaching him. And there are enough being enough consulting about it in Washington; there is time enough for their judgment to outweigh the ambitious brawlers, and we take it for granted that a party blunder will not be committed.
