DECLARATION OF INDEPENDENCE,

JULY 4, 1776.

THE UNANIMOUS DECLARATION OF THE THIRTEEN UNITED STATES OF AMERICA EN COUNCIL ASSEMBLED.

When in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them; and to assume among the powers of the earth, the separate and equal station to which the laws of nature and of nature's God entitle them; a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness; that to secure these rights, governments are instituted among men, deriving their just power from the consent of the governed; that whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute new government, laying its foundation on such principles, and organizing its powers in such forms, as to them shall seem most likely to effect their safety and happiness. Prudence, indeed, will dictate that governments long established should not be changed for轻率的改变; but, according to the principles of our Government, that all experience hath shewn that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security. Such has been the patient sufferance of these colonies, and such is now the necessity which constrains them to alter their former systems of government. The history of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let facts be submitted to the world;

He has refused his assent to laws the most wholesome and necessary for the public good.

He has forbidden his Governors to pass laws of immediate and pressing importance, unless suspended in their operation till his assent should be obtained; and, when so suspended, he has utterly neglected to attend to them.

He has refused to pass other laws for the accommodation of large districts of people, unless those people would relinquish the right of representation in the legislature—a right inviolable to them, and formidable to tyrants only.

He has called together legislative bodies at places unusual, uncomfortable, and distant from the repositories of their public records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved representative houses repeatedly for opposing what he deemed his invasions on the rights of the people.

He has refused, for a long time after such dissensions to cause them to be解散ed, whereby the legislative powers, incapable of annihilation, have returned to the people at large for their exercise—the State remaining, so far as the imagination, exposed to all the dangers of invasion from without, and consubstantiation within.

He has endeavored to prevent the population of these States—for that purpose obstructing the laws of naturalization of foreigners, refusing to admit others to encourage their emigration either, and raising the standard of corruption in appropriations of lands.

He has obstructed the administration of justice by refusing his assent to laws for establishing judiciary courts.

He has made judges dependent on him, will give to the friends of their offices and the amount and payment of their salaries.

He has created a multitude of new offices, and so high salaries of officers to increase our taxes and of these salaries.

He has kept us in a state of peace standing armed, without the consent of our legislature.

He has affected to render the military independent of, and superior to, the civil power.

He has combined with others to subject us to a jurisdiction foreign to our Constitution and unacknowledged by our laws giving his assent to their acts of pretended legislation.

For protecting them, by a mock trial, from punishment for any murders which they should commit on the inhabitants of these States;

For cutting off our trade with all parts of the world;

For imposing taxes on us without our consent;

For depriving us, in many cases, of our right of trial by jury;

For transporting us beyond seas to be tried for pretended offences.

For violating the free ports of our neighbors, giving therein an arbitrary government, and enlarging its boundaries, so as to render it at once an example and its instrument for introducing the same absolute rule into those colonies;

For taking away our charters, abolishing our most valuable laws, and altering fundamentally the forms of our government;

For suspending our own legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever;

He has abdicated government here by declaring us out of his protection and waging war against us.

He has plundered our seas, ravaged our coasts, burnt our towns, and destroyed the lives of our people;

He is at this time transporting large quantities of foreign mercenaries to complete the work of death, desolation, and tyranny, already begun with circumstances of cruelty and perfidy scarcely paralleled in the most barbarous ages, and scarcely worthy the head of a civilized nation.

He has constrained our fellow citizens taken captive on the high seas, to bear arms against their country, to become the executioners of their friends and brethren, up to full satisfaction by their hands.

He has excited domestic insurrections amongst us, and has endeavored to bring on us, in concert with our enemies, a general massacre of the inhabitants of our frontier towns, whose known rule of war
