H. Caldwell, Committee to report resolutions in relation to the proposed election of a member of the Board of Commissioners.

2nd. That we specially disapprove of the wanton disregard of the people's rights and interests, evinced in their wicked, un-Christian, and un-American, and un-democratic, vote of the 18th inst.

3rd. That it behooves every good and true citizen who loves his State and his country, and who is not content with simply thinking and hoping, but work for the cause.

4th. That we the Conservatives of Rockingham, do hereby declare that we are in favor of all law and violence, which will Ku Klux, Loyal Leagues, or other organizations whatsoever.

5th. That we fully acquiesce in the positive law of the land which gives to the colored man equal rights.

6th. That we invite all honest men without regard to race or color, to cooperate with us in supporting the party now in office with an undivided political power, to the end that peace, harmony and prosperity may once more reign in the land.

7th. That we as representing the taxpayers of this county, do hereby approve the course pursued by Messrs. G. I. Allen, Wm. W. H. B. Bissett, J. H. Caldwell, J. M. Johnston, and J. F. Patton, in forming the party now in office by the Board of Commissioners of this county, and we do hereby thank them for their patriotic action.
