By them it will be seen that there are fifty of our dead interred at Gettysburg, and that if they are not removed very soon, the owners of the land therein to plough up the fields and convert the human bones into fertilizers.

The U. S. vs. W. T. Shipp, charged with delaying letters, was taken up. The U. S. District Attorney, Starbuck, appeared for the government and H. C. Badger for the defendant. The case was submitted without argument under charge of the court. The jury returned a verdict of guilty.

In the afternoon the injunction case of Anthony Swamy et al. vs. N. C. R. R. and officers and D. A. Jenkins, Treasurer of North Carolina, was taken up. This case is brought to enjoin the Public Treasurer from using the dividends declared on the state's stock in the road for purposes other than the payment of interest on state bonds, and asking the court to appoint a receiver on the part of the state bondholders. Messrs. Phillips & Merrimon and R. C. Badger, of this city, C. Oshing, of Washington, D. C., and Messrs. W. J. Duld and T. C. Brewer, of Philadelphia, appear for the plaintiffs. The defence is represented by Attorney General Shipp, B. F. Moore and Battle & Sons of this city.

DEAR MADAM:—Enclosed is a list of the names of the North Carolina dead now lying at Gettysburg, whose graves can be identified by the original record and plot of the ground, as seen by our president, Mrs. M. A. Snowden, in her recent visit to the deserted resting place of our martyrs dead.

Mrs. S. had the list copied, hoping to induce our sister associations to engage in the like sacred duty, as we lately engaged in ourselves, for we have brought home to their native soil, the remains of 60 gallant spirits, whose last prayer was to be taken home. Brought them not only from the deplorable graves in which they were lying, but from worse, for the owners of the grounds have given notice that next year they intend ploughing it up, and will grind up the bones to use as fertilizer.

This thought is fraught with such horror, that we hope it will induce your association to act. The thought that our noble martyrs should be denied a last resting place is unbearable. Mrs. S. who visited Gettysburg in person, and saw all the graves, is perfectly satisfied that we have the remains we wished, for the record is correct, and the graves easily identified by Dr. Weaver, the person we employed, and whose father kept the record, so this fear or doubt need not deter you. One thing more; if you set at all in this matter, and we trust your association will; it must be speedily, for Dr. W. will remove from Gettysburg in the Autumn; he is there now, and will be till August, and we can not readily find another to you for the work, being kind, efficient and zealous. His charges are very moderate, as he disinters, boxes up carefully, and nicely, and delivers in Baltimore, for not quite \$1 for each disinterment.

There are several hundreds more of our brave Southern dead from this famous battle, whose names are unknown, and whose bodies cannot be separately identified. These we hope the Hollywood Memorial Association, of Richmond, will take charge of, as they have given notice of their intention to do so. I believe the people of each State have contributed funds for the purpose, at least I know ours have. I must not omit to state that numbers of ladies of Baltimore who nursed at the battle, after the battle, mentioned to Mr. S. the touching fact that every one of the poor fellows they had nursed there, without an exception, expressed their willingness to die for their country, but begged that their bodies might be sent or taken home to their State. Trusting this appeal will meet with a favorable response from your Association and assuring you we will cordially afford you all the information we possess on the subject at any time.
