STATE OF NORTH CAROLINA.

TREASURY DEPARTMENT.

Raleigh, N. C., June 16, 1871.

To the Sheriff of the several Counties

in North Carolina:

I have cause to believe that many agents of non-resident persons are carrying on business under Section 23, Schedule B, of "An Act to raise Revenue," without having obtained the license required in law.

It is the duty of Sheriff to see that the Revenue Laws are not evaded in their respective counties, and you are enjoined to observe due diligence in preventing a violation of the same.

Special attention is called to the provisions of said section which have been transmitted to you with Circular from this Department.

You, as Sheriff, and your Deputy or other officer, any party or person who may be deputed in the execution of the section mentioned, and in case of conviction, rightly enforce the penalty therefor.
