AN ACT TO CHANGE THE TIME FOR HOLDING THE SUPERIOR COURTS OF ALAMANCE COUNTY.

Be it enacted by the General Assembly of North Carolina, etc.: That after the 1st day of January, 1872, the Superior Courts for the counties of Alamance, Orange, and Guilford, on Monday before the last Monday of March and September of each year.

Sec. 1. That all process, recognizances, and other legal proceedings, which will be entered and filed, or have already been issued or recorded, be issued and returned to Spring term, 1872, of said court, shall between 10 and 12 o'clock, referable to the term, and so far as the law permits, to all persons who have been recognized or bound or summons to appear at the Spring Term of said court for the year 1871, hereby remain to the term of 1872, and the Secretary of State shall furnish the Sheriff and the Clerk of the Superior Court of Alamance County, a copy of the same.

Sec. 2. That all laws and parts of laws inconsistent with this act are hereby repealed.

Sec. 3. This act shall be enforced from and after its ratification.

In the General Assembly read three times, and ratified the 4th day of December A. D. 1871.
