AN ACT TO CHANGE THE TIME FOR HOLDING THE PERIODIC COURTS OF ALAMANCE COUNTY.

Sec. 1. The General Assembly of North Carolina do enact: That after the 1st day of January, 1872, the Superior Court of the county of Alamance shall be held on the second Monday before the 1st Monday of March and September of each year.

Sec. 2. All public process, recognizances, and other legal documents, with the criminal actions which have already been issued or may hereafter be issued and held, returnable to Spring Term 1872 of said court, shall be drawn at the time of trial, and the same shall be sent to the sheriff by this act, and all persons who have been recognized or bound or summoned to appear at the Spring Term of said court for the year 1872, are hereby required to appear at the time of trial, and the same shall be sent to the sheriff by this act, and the sheriff and the Secretary of State shall forthwith cause this act to be published and furnish the Sheriff and the Clerk of the Superior Court of Alamance, with a copy.

Sec. 3. All processes, writs, and writs of habeas corpus, and all other legal documents, in accordance with this act are hereby repealed.

Sec. 4. This act will be enforced from and after its passage.

In general assembly read three hours and ratified the 5th day of December A. D. 1871.
