**AN A.T.T. TO CHANGE THE TIME FOR HEADING THE SUPERIOR COURTS OF ALABAMA.**

Sec. 1. The General Assembly of North Carolina do enact:—That after the 1st day of January 1872, the Superior Courts for the county of Alabama shall be held on the second Monday before the 1st Monday of March and September, inclusive.

Sec. 2. That all previous recognizances and other legal process lies, in civil and criminal actions which have already been issued or may hereafter be issued, shall be returned to the court in which they were issued, and the same shall be set aside, and new issued by the court in which they were issued, to the same parties, and furnish the Sheriff and Clerk of the Superior Court of Alabama, with a copy.

Sec. 3. That all laws and parts of laws inconsistent with this act are hereby repealed.

Sec. 4. That this act shall be introduced from and after its ratification.

In General Assembly read three times and ratified the 4th day of December A. D. 1871.
