AN ACT TO CHANGE THE TIME FOR HOLDING THE SUPERIOR COURTS OF ALAMANCE COUNTY.

Be it enacted by the General Assembly of North Carolina, that after the 1st day of January next, that all trials in the courts of Alamanca, shall be held on the second Monday before the 1st Monday of March and September of each year.

Sec. 2. That all process, pleadings and other legal papers, in civil and criminal actions which have already been issued or may thereafter be issued, and had returnable to Spring Term 1872 or from time to time, and all persons who have been recognized or bound or summoned to appear at the Spring Term of said court for the year 1872, are hereby required to appear at the term of Alamanca in this year, and the time of State shall forthwith cause this act to be published, and furnish the Sheriff and the Clerk of the Superior Court of Alamanca notice thereof.

Sec. 3. That all laws and parts of laws inconsistent with this act are hereby repealed.

Sec. 4. This act shall be enforced from and after its ratification.

In General Assembly read three times and ratified the 4th day of December A. D. 1871.
