A heavy business was done yesterday by the Commission Merchants on Exchange Place and Martin Streets in the cotton line. The price of this staple has increased considerably within the past few days, now bringing 18 1/2 cents per pound. We understand that from 50 to 150 bales arrive daily, and that as much as 12,000 bales have been received within the city since the beginning of the present season. This speaks well for the increase in the business importance of Raleigh. We were shown by the senior member of the firm of Chastain &amp; Son, a sample of middling cotton of which he had just received 12 bales, raised in Chatham county, which could not be excelled by anything in the cotton line raised anywhere in the South, other than the Sea Island cotton.

Mr. Chastain informed us that the Northern Merchants now ranked North Carolina cotton as high in quality as that from any other Southern State.

This great improvement in the staple is owing to the necessity to which our people have become attached of the necessity of extensive fertilization, and the many recent improvements in the manufactured machinery for its ginning.
