## A CALICO TAFFET.

On Monday last a bolt of calico and a pair of shoes were stolen from the store of Alexander Caeche, at the corner of Fayetteville and Hargett streets. On yesterday morning Mr. Freeman, who is attending to Mr. Creech's business during his absence at the North, heard that the calico had been sold to Mr. Frank DeForest, salesman at Mr. Anns Upchurch's saloon, on Wilmington street. Mr. Freeman, with the Chief of Police, visited the saloon, identified and took possession of the calico. Mr. DeForest stated that he had purchased the calico from a colored woman named Harriett Whitsaker. A warrant was issued and Harriett arrested and taken before the Mayor. She failed to give any satisfactory account of how she got possession of the goods, and the Mayor sent up to send her on, she could not give the required bond, and was committed to jail.

## A HALF ACER.

The above is the appropriate name of a certain locality in this city which has again become notorious for drunken rows and general disorders. It is situated in the Southern portion of the Western Ward, and has borne its present high-sounding name for more than a quarter of a century. The persons who live on and frequent the Acre, as a class, are the meanest and most degraded specimens of humanity, and their low depths of baseness and their drunken, midnight orgies, justly entitle it to the name of "Hell's Half Acre." On yesterday morning Fab. Chavis, a respectable colored man, who lives in the neighborhood of the Acre, made complaint and had the following symptoms brought before the Mayor, charging them with keeping a disorderly house: Jane Crocker, Annie Yates and Ella Stephens. Dr. Hester, col. and Fab. Chavis, col., were examined and testified that it was not unusual for all hands to get drunk and indulge in loud swearing and the use of obscene language, often ending in a free fight, to the disgust and annoyance of the good people of the neighborhood. They were all drunk and engaged in a fight on Monday last, Jane, the proprietress of the house, acknowledged that she kept a house of ill-fame and that drunkenness and disorderly conduct was common on the premises. The Mayor informed her that she was liable to a fine of \$10 for every day that she kept a house of ill-fame. He would bind the three over to court in the sum of \$200 each. They would not give the required bond and went to jail.
