## HOME AFFAIRS.

**Col. Morehead suggested that the bond**  
would be a far insufficient sum unless  
some limit was placed upon the sale of  
the mortgage bonds for in the bill.  
Mr. Waring was willing to accept the  
suggestive amendment of the third read-  
ing.  
Mr. Humphrey spoke earnestly against  
the amendments, said they were intended  
as a cloak.  
Mr. Worth said the bill would never  
with an adequate guarantee for the  
protection of the State against frauds, and  
supported the amendment.  
Mr. Love said that the bond when  
given would not be worth the paper it  
was written on. That brains and money  
did not always run in the same channel;  
that he wanted brains in this great work  
as well as money.  
Mr. Cowles favored the amendment, he  
thought there was a solemn warning con-  
tained in the history of recent railroad  
frauds and defalcations, and he for one  
would not feel that he had discharged his  
duty, until he had voted for every reason-  
able safeguard for the protection and se-  
curity of the people's money. As the bill  
stood there was no pecuniary responsi-  
bility attaching to the President and  
Directors of this gigantic corporation, with  
the bond and proper restrictions in regard  
to the sale of the bonds there would be ample  
security.

**Dr. Murphree, Mr. Love and Colonel**  
Humphrey approved the amendment.  
Mr. Norwood moved to reduce the  
bond to \$100,000. Not agreed to.  
The amendment of Senator Waring was  
adopted, 23 to 9, under a vote of yeas and  
nays.

price should be uniform.  
Mr. Humphrey moved to strike out  
sections 6, 7 and 12. Adopted.  
The 6th section makes the term of the  
Directors and President 5 years.  
The 7th allows the Company to issue  
certificates of stock to any amount pro-  
vided the par value of the same shall not  
exceed the cost of construction and com-  
pletion of the line.  
The 12th authorizes an increase of capi-  
tal stock, and allows cities, towns and  
counties to subscribe.
