Legislature of North Carolina.

SENATE.

February 7. The Senate met, at the usual hour, Lt. Gov. Bragg in the chair. The Journal of yesterday was read and approved.

REPORTS.

Mr. Norwood, from the committee on agriculture.

Mr. Cunningham's report was a resolution as a substitute for the bill providing the publication of Wheeler's Manual of North Carolina. The resolution which was adopted, provides for the printing of the Manual as other legislative matter.

Mr. Love, from the committee on propositions and grievances, reported back the various propositions which constitute the Education Bill, with the recommendation that they be placed on the calendar, and also unfavorably on the Omnibus bill. It was stated as his reason for passing this course was on account of the rebuke offered to the committee by the Senate in passing Mr. Miller's bill, which should have been included in the Omnibus bill.

On motion of Mr. Norwood, the rules were suspended, and the bill to amend sec. 13 chap. 27, Battle's Revisal passed its second reading. The bill provides that the various commissions may advertise the transactions of the board, heretofore required to be published in the county newspapers, either by pasting at the Court-house door as formerly.

Mr. Waring, under a suspension of the rules, called up his bill to amend chapter 193, laws of 1873-74, in regard to fences in this county which passed its readings.

On motion of Mr. Scott the rules were suspended, and the bill for the better protection of the records in the Secretary of State's office was taken up and passed its several readings.

Resolution in favor of Josiah Turner, Jr., providing for the payment of \$520, on account of public printing passed its readings.

BILLS RESOLUTIONS AND MOTIONS. By Mr. Welch, a bill to amend sec. 14, chapter 105, Battle's Revisal. Referred.

By Mr. Miller, a bill to prohibit the sale of liquor within two miles of the town of Shelby, Cleveland county. On motion of Mr. Miller, the rules were suspended and the bill passed its several readings.

By Mr. Allen, a bill in reference to an inspector in the city of Wilmington. Referred.

By Mr. Grandy, a bill to authorize B. F. Spencer to purchase land in the county of Caswell.

By Mr. Powell, a resolution requiring the Attorney General to enquire into the validity of the title to the property known as Camp Mangum.

By Mr. Murphy, a bill relating to the board of public charities. Referred.

SPECIAL ORDER. The Machinery Act came up on its third reading as the special order at 12 1/2 o'clock, and after the adoption of several unimportant amendments passed its final reading by aye 17, nays 10.

HOUSE OF REPRESENTATIVES. Feb. 7th, 1874. Mr. Speaker Robinson called the House to order at 10 1/2 a. m.

Journal of yesterday was read and approved.

MORNING BUSINESS. Mr. Richardson petitioned from the Chamber of Commerce of Wilmington against the passage of the usury law.

Mr. Bennett, a petition from a part of the citizens of Anson county in regard to the prohibition of the sale of liquor near Deep Creek church.

Hughes, colored, petition of citizens of Granville county against the prohibition of the sale of spirituous liquors in one and a half miles of Pleasant Grove Baptist church, in said county.

REPORTS FROM COMMITTEES. Mr. Bennett submitted report from committee on judiciary.

Mr. Brown, of Mecklenburg, from committee on propositions and grievances.

Mr. Standford, from committee on finance.

Mr. Gladley, from same committee.

Mr. Moring, from committee on engrossed bills.

Mr. Trivett and other members of the House presented a protest as to a particular clause in the consolidation railroad bill. The speaker ruled it out as disrespectful to and impugning the motives of members of this House.

On motion of Mr. Bennett, the rules were suspended, and the resolution asking the opinion of the Supreme Court touching the right of the General Assembly to order an election on the 1st Thursday in August, 1874, for two Supreme Court Judges, &c.

Mr. Craig moved to indefinitely postpone.

The House refused to postpone—ayes 38, nays 32.

The resolution favor of Josiah Turner, Jr., passed several readings and was ordered to be engrossed and sent to the Senate.

The bill to prohibit the sale of liquor in townships where the people so determine was read.

Mr. Freeman offered an amendment that it should not apply to McDowell county.

Mr. Moss that it should not apply to Wilson.

Various other amendments were offered and rejected and the bill passed second reading.

Bill to authorize the commissioners of Blaine county to levy a special tax, passed its second reading.

The bill to authorize the commissioners of Jones county to levy a special tax passed its second reading.

Senate bill to authorize the town of Hickory, in the county of Catawba to issue bonds to aid the C. C. Railroad Co. passed its second reading.

The bill to prohibit the demanding of tolls at Sandy Bottom in Buncombe county was read and passed its several readings.

The bill to amend chapter 171, laws of 1873-74, passed its several readings. This bill prohibits the sale of all "bitter" or liquor under any disguised name in four units of Mt. Pleasant Academy, Cherokee county.

The bill to amend chapter 28, private laws of 1869-70, passed several readings. The bill in relation to shooting or making mountain trout in the waters of Elk river and tributaries in the counties of Mitchell and Watauga, passed its several readings.

The bill to empower the city of Wilmington to subscribe to the special stock of the Wilmington & Seaside Railroad Company, passed its several readings.

The bill to authorize the commissioners of Sampson county to levy a special tax its second reading.

House adjourned at 2 o'clock and ten minutes.
