Horrible Outrage.

A Young Lady Raped by a Negro.

We learn by a telegram just on the eve of going to press, that a horrible rape was perpetrated near Morrisville to day, twelve miles from this city, a station on the North Carolina Railroad by a black man of about 20 years of age.

But few particulars are given, though the whole country is in an uproar as represented, and the most intense excitement prevails, without stating whether or not the wretch had been captured.
