GENERAL ASSEMBLY.

SENATE. February 12.

President Armfield in chair. Prayer by Rev. Mr. Wagoner. Clerk read journal of yesterday.

Mr. Lacey, bill supplemental to the charter of the town of Statesville. Referred.

House resolution asking our representatives in Congress to urge the repeal of taxes on issues of State banks came up and was unanimously adopted.

PERSONAL PRIVILEGE. Mr. Bell rose to personal privilege on the Klinton Gazette. It had an article in its last issue reflecting on the eastern members as to their course about Convention. An assistant editor of that paper he knew nothing about the article and had no sympathy with its words.

Mr. Parish, bill allowing trustees of Bingham Township to collect arrears of taxes. Referred.

House bill to allow commissioners of Currituck to fund the debt and levy a special tax passed third reading.

CHARTER OF RALEIGH. Motion of Mr. Busbee, rules suspended, and bill to amend charter of the city of Raleigh, put on its several readings. It divides the city into five wards. It gives the 2d Ward five Aldermen, and all the rest three each. That the Board of Aldermen shall elect the Mayor, but not of his own number, and for misconduct in his office the Mayor may be removed by a vote of three-fifths of the Board.

Tucker amended to leave it to a vote of the city. Mr. Cantwell amended to strike out 90 in section 4th and insert 30 days where it occurs. Voted down. Bill passed third reading, aye 38, nays 6, and will go the House for concurrence in certain amendments.

Mr. Kerr bill to amend certain sections of laws of 72-74.

Bill to incorporate Direct Trade Union, P. O. H. passed third reading.

Bill incorporating First Greek Baptist Church in Alleghany county passed third reading.

Bill allowing commissioners of Bladen county to levy special tax passed second reading.

Mr. Taylor's bill in regard to Bevard Transylvania county, passed third reading.

Mr. Parke, the rules suspended and bill to charter bank at Durham passed its third reading.

Bill to amend charter of Wake Forest College and appoint Trustees passed third reading.

A HOUSE OF REPRESENTATIVES. At 11 a. m. Mr. Speaker Robinson called the House to order.

The Journal of yesterday was read and approved. Messrs. Bennett, Candler, McRae and Sharpe, presented petitions.

Messrs. King, Finger and Walker of Richmond, submitted reports from standing committees.

Mr. Oaksmith, resolution in regard to Federal relations. Referred.

Mr. Eastman, resolutions in favor of amending the State Constitution by legislative enactment. Referred.

Mr. Walker of Richmond, bill to establish the city bank of Wilmington. Referred.

Mr. Hervey, bill to allow the commissioners of Montgomery county to levy a special tax. Referred.

Mr. Dotch, bill for the relief of Mike Woods. Referred.

Mr. McRae, bill to prevent the sale of liquor within three miles of Cumberland Union church, Cumberland county. Referred.

FROM WASHINGTON. WASHINGTON, Feb. 11.—In the Senate, McCreery, of Kentucky, introduced a bill setting forth that it had been reported in a responsible medical journal of the United States that a certain gentleman of

Mr. Oaksmith offered a substitute. Mr. Glenn took the floor and again explained the motives for introducing the original resolutions. He stood exactly as he did on Monday. He moved to postpone the resolutions until Thursday. He made the motion for the purpose of allowing friends, who thought as he did, time to set considerably in the matter.

Mr. Foster endorsed Mr. Glenn and hoped the postponement would take place.

After some remarks by Mr. Walker of Richmond, the motion to postpone was put to a vote and carried unanimously.

The consideration of the navy bill was resumed. The question occurred on Mr. Meigs' amendment. Mr. Meigs moved to amend the amendment by inserting after the word "apply" the words "equally in all respects." The amendment was adopted and the question then occurred on the amendment of Mr. Meigs as amended.

Mr. Strong next took the floor in advocacy of the amendment in remarks of length. He did not think this bill would at all reach those national banks.

At the conclusion of Mr. Strong's remarks the House adjourned.
