City Intelligence.

Mr. Ford the penitentiary guard is not dead as our exchanges insist in having it.

The artillery company of this city will fire one hundred guns on the morning of the 20th of May.

Mr. J. Jessup was not elected Auditor of the Western Railroad at the railroad meeting in Fayetteville but conductor.

The Second Baptist Church as enlarged will be ready for worship to-morrow. The revival still continues, over one hundred converts.

The annual meeting of the Memorial Association will be held in the Session Room of the Presbyterian Church on Monday, at 4 1-2 p. m.

A THIRD BAPTIST CHURCH—A third Baptist church in this city is an established fact. Those enterprising Baptists met yesterday evening at their church and determined to build a thirty thousand-dollar church.

ONE MORE.—One more is in the pen, a negro brought down by sheriff Jones, from Yadkin county, this morning. He stole corn and was sentenced for four years to eat the State's rations and pitch rocks for exercise unless he sees fit to chop up a guard with a hatchet and make his escape before the end of his term.

Woodson has joined the Good Templars, so it will not be as "it used to be," when Boss Tweed's ring furnished \$10,000 to run the paper, and Woodson furnished what old Jo. Woods called "sin; songs, etc."

PERSONAL STREET METHODIST CHURCH.—There will be a Sabbath School prayer-meeting at this church to-morrow morning at 9 1-2 o'clock. Reception of members and the administration of the ordinance of baptism at 10 1-2, and preaching at 11 a. m. At 3 1-2 p. m. prayer meeting and preaching at 7 1-2 p. m. Rev. R. A. Willis will officiate morning and evening. We learn that the revival of religion at this church continues with unabated interest. About 80 have professed faith in Christ, and there are a large number of penitents, earnestly seeking salvation through Christ. The postal card was sent Major Bagley by John W. Hinesdale of Fayetteville who owns a machine for which he paid one hundred and twenty-five dollars. The machine has 26 keys, a key for every letter in the alphabet. Mr. Hinesdale says it saves him one-third of his time and he can do five times as much writing with it in the same space of time as he can with a pen.
