desire to give a correct statement of the
matter.

The two-mile load weighed 1,540
Tare on " " 300

ONE MILE SHEDDING TIME

The ox-cart load weighed 1,940

Tare on " " 1,500

NET. 440

The total weight of both is 1,180

The above is a correct statement
from the receipt book in my possession,
which is open for inspection. The reason
of the difference in the two loads
arises from the fact that in weighing a
two-horse load, the team stands off the
scales, while a one-horse cart the horse
(or ox) stands on the scales and is
therefore included in the gross weight.
