

PROCLAMATION. By the Governor of North Carolina. I'wo Hundred Dollars Reward.

WHEREAS it has been made known to me, that a murder has been committed in the county of Currituck, and State of North-Carolia, on the 4th of September last, and that a cerrais IVEY WILKINS, late of the county & State aforesaid, stands charged by the verdict of a coroner's inquest with having perpetrated the same on the body of a certain Penclope Wilkins, of said county :- and as it is further represented and made known to me that the said livey Wilkins bath absconded and fled from the jurisdic. tion and limits of this State, and thereby eluded the arm of the law and of justice :

Now therefore, to the end that the said Ivey Wilkins may be apprehended and brought to justice, the above reward of two hundred dolhars will be given to any person or persons, who will apprehend and confine the said Ivey Wilkins in any jail in this State, so that he may be brought to justice : And I do moreover hereby equire, command and enjoin all officers whatsuever, as well civil as military, within this State, to use their best endeavours to apprehend and take, or cause to be apprehended and taken, the body of the said lvey Wilkins, and him safely and securely keep, so that he shall be brought to justice.
