A Speck of War Among Georgians—Unpleasant Exits for Governor Bullock.

The meeting of the Reconstruction Convention, this morning, to consider Governor Bullock's case, was quite exciting. Mr. Wilson Tift, who has been appointed to succeed Governor Bullock, was the only one who spoke in favor of the Governor. He declared that Governor Bullock was guilty of a violation of his oath to support the constitution of Georgia. That he (Bullock) was in conscience bound to protect the interests of the people of that State. But, said Mr. Tift, there are good reasons for Governor Bullock's conduct in seeking to have the Georgia Legislature impeached. It was well known that charges against his character and official conduct were before the Legislature of that State, and Bullock had reason to fear that he would be punished. If Bullock had his desire, said Tift, he would be impeached by the Georgia Legislature, and if case is ever passed upon by an impartial judiciary he (Bullock) would be transferred from the gubernatorial chair to the Penitentiary of Georgia. Governor Bullock was present while Tift made his remarks, and he was very angry. He jumped from his seat, and exclaimed he could not sit still while his character was thus abused. He had no objection to the severest criticism of his official career, but his private character must not be thus assailed in his presence. Mr. Tift replied to this interruption promptly, and Bullock took his seat quietly. It was feared that a personal collision would result from the affair, but up to the present time nothing of the kind has occurred.—*Washington Correspondent N. Y. Herald, Dec. 20.*

The Chatham Road.

A correspondent of the *Washington Journal*, writing from Fayetteville says:

When this Chatham Road will reach Jonesboro is, as yet, very uncertain and the general impression is that it will be years before it penetrates to Cheraw, the original intended terminus of the road.

Reports there at all, notwithstanding the assurance of Dr. Hall, who, it is said, has always been considered in railroad affairs. This gentleman, Punderstand, has declared his determination to build his road through to Cheraw under any circumstances, and he asserted his ability to do it without aid from either North or South Carolina. In view of the pushed state of affairs it is safe to assume that if the road is completed at all during the next fifteen or twenty years, it will be without the assistance of either of these Commissions. The State of South Carolina has lately refused to aid the enterprise, and it is well known that North Carolina bonds are fast reaching the present standard of those issued by our late Confederacy.
