#### COWPENS.

The bronze statue of Morgan unveiled at Spartanburg, South Carolina, on the 12th of May, was contributed by Congress, and the granite base and pedestal of the monument were built by the joint contributions of the old times antecedent to the nomination of thirteen states and Tennessee.
