The announcement of the appointment of registers for the different counties of North Carolina, by General Sickness, shows that the highly important work of registration is to commence without delay.

Although this process of registration seems to be quite well understood, we cannot too strongly urge its importance upon every voter. In the first place, let it be universally understood that while the act of registration does not mean voting, that no man will be permitted to vote unless his name is first properly registered.

In the event that registration is thus left exclusively to the boards already selected, it will be seen the labor to be performed is by no means a trifling one. We think, however, that the registers selected will prove equal and competent to the task.

leading to the fact to be established, as one taken by itself amounts to nothing. For illustration, it is argued that the father killed his child with a gun - this puts the gun on him. He proves that the child was not killed by the gun, but that the gun was out of repair, so that it would sometimes go off at half-cock by a jar or sudden motion, and that at the instant it went off he made an exclamation of surprise and exhibited the usual emotions of grief, which would be admissible as part of the res gestae. Here is a chain of circumstances proper for the consideration of the jury. In our case there is a middle link, that is, the lock was out of order and would not stand at half-cock, but the prisoner is content with the fact that the State has offered no evidence of any will or negligence on the part of the deceased, so the link on that side is wanting, and so far from being a link on the other side, so as to make a chain, the evidence is that, without expressly saying he threw down the gun, picked up his pistol, and made his escape, and when arrested, put the gun in his pocket, he did not know it was loaded. Thus the evidence in regard to the lock stands alone in reference to the allegation that the gun went off accidentally, and is hardly sufficient to suggest a conjecture that such might have been the fact.

We fully approve the charge of the Hon. Judge upon the subject of insanity, "It is a delicate, sensitive and accurate; and as it is difficult to convey to the minds of jurors, it is the duty of the judge, so far as possible, to call the attention of the other Judges to the charge." There is no error in this opinion, which will be certified to the Court.

BOARD OF REGISTRATION.

HEADQUARTERS SECOND MILITARY DISTRICT, NEW BERN, N. C., July 19th, 1867. GENERAL ORDERS, July 19th, 1867. No. 60. To all my beloved and patriotic fellow-citizens: The following appointments of Registers are announced. The persons named will be assigned to duty by Post Commanders as members of Boards of Registration for the several Counties and Precincts within their respective commands. Each Board and Precinct will be organized and their action taken by their respective Post Commanders. Two Boards of Registration will be organized for each County in North Carolina having more than six election precincts, except the Counties of Beaufort, Cumberland, Craven, Edgecombe, Granville, Halifax, New Hanover, Wake, Davis, and Wilson, which shall have the Boards provided for in the order of the Board of Registration for each County. The Boards of Registration for each District in South Carolina, except the Districts of Barnwell, Beaufort, Orangeburg, Lexington, Colleton, Greenville, Chester, Colleton and the city of Charleston, which shall have the Boards provided for in this order.

Registers will be required to take the oath prescribed by the Act of Congress approved 3d July, 1862. Blank forms of this oath of office will be furnished to Post Commanders, and when duly subscribed and sworn will be returned to these Headquarters.

The election precincts established by law or custom as voting places in the Counties and Cities of North Carolina and in the Districts, Parishes and Municipalities of South Carolina, will be designated by Post Commanders as the places for Registration. It is desirable that no more than six persons, and preferably a number not including a Radical, be assigned to each District or Precinct, so that ample facilities may be afforded for Registration.

Every Board of Registration will choose its presiding officer, who will represent the Board and announce its action upon all matters coming before it.

Regulations for the government of Registers in the discharge of their duty will be daily published as soon as practicable for general information.
