OF THE QUALIFICATIONS AND GEN ERAL DUTIES OF CLERKS OF THE SUPERIOR COURTS.

Sec. 1. At the first meeting of the county commissioners of each county after the election or appointment of any Clerk of a Superior Court, it shall be the duty of the clerk to deliver to such commissioners a bond, with sufficient sureties, to be approved by them, as is now required by the law, payable to the State of North Carolina, and with a condition to be void if he shall account for any [and] pay over according to law all monies and effects which have or may come into his hands by virtue or color of his office, and shall diligently preserve and take care of all books, records, papers and property which have come or may come into his possession, by virtue or color of his office, and shall in all things faithfully perform the duties of his office. BONDS HOW APPROVED, &C. Sec. 2. The approval of said bonds by the commissioners, or a majority of them, shall be recorded by their clerk, any commissioner dissenting may cause his dissent to be enter ed on record. Any commissioner approving a bond which he knows or believes to be insufficient, shall personally be liable as if he was a surety thereto. SECOND CONCINESSIONAL DIS ARTICLE IV.

JUDICIAL DEPARTMENT Section V. The distinction between actions at law Scetter I. The distinction between actions at law and suits in equity, and the forms of all such actions and suits shall be abolished and there shall be in this State but one form of action, for the enforcement or protection of private sights or the redress of private wrongs which stuff be denominated a civil action, and every action presented by the people of the State as a party, against a person charged with a public offence, for the punishment of the same, shall be termed a criminal action. Feigned issues shall also be abolished and the fact at issue tried by order of court before a fury.

Sec. 2. Three Commissioners shall be appointed by this convention, to report to the General Assembly at its first session after this constitution shall be adopted by the people, rules of practice and procedure in accordance with the previsions of the foregoing section, and the convention shall provide for the commissioners a reasonable compensation. reasonable compensation.
Sec. 3. The same commissioners shall also report to

the General Assembly as soon as practicable, a code of law of North Carolina. The Governor shall have power to fill the vacancies occurring in this commission.

Sec. 4. The judicial power of the State shall be vested in a court for the trial of impeachments a Supreme court, Superior courts, court of justices of the Peace and special courts. court, Superior courts, court of justices of the Peace and special courts.

Sec. 5. The court for the trial of impeachments shall be the senate; a majority of the members shall be necessary to a quorum, and the judgment shall not extend beyond removal from and dequalification to hold pflice in this State, but the party shall be liable to indictment and punishment according to law.

Sec. 6. The House of Representatives salely, shall have the power of impeaching. No person shall be convicted without the concurrence of two-thirds of the Senators present. When the Governor is impeached the Chief Justice shall preside.

Sec. 7. Treason against the State shall consist only in levying war against the State shall consist only in levying war against it or adhering to its enemies, giving them aid and comfort. No person shall be convicted of treason unless on the testimony of two witnesses to the same over act, or on confession in open court. No conviction of treason or attained shall work corruption of blood or forfeiture.

Sec. 8. The Supreme court shall consist of a Chief Sec. 8. The Supreme court shall consist of a Chief Justice and four Associate Justices,

Sec. 9. There I shall be two torms of the Simrem Sec. 9. There ishall be two torms of the Simprema court held at the seat of government of the State in each years, commencing on the first Monday in January, and first Monday in Jube, and continuing as long as the public interest may require.

Sec. 10. The Supreme court shall have jurisdiction to review, upon appeal, any decision of the courts below, upon any matter of lay or legal interference; but no issue of fact thall be tried before this court; and the court shall have power to issue any remedial write necessary, to give it a general supervision and control of the interior courts.

Sec. 11. The Supreme Court shall have original jurisdiction to hear claims against the State, but its decisions shall be merely recommendatory; no process in the nature of execution shall issue thereon; they shall be reported to the next session of the General Assembly for its action.

But their terms shall begin upon the approval of this Constitution by the Congress of the United States.

The screenl justices at the peace shall have exclusive original jurisdiction under such regulations as the General Assembly, shall screening of all divil actions founded on contract, wherein the sum demanded shall not exceed two hundred doilars, and wherein the title to real estate shall more be in controversy, and of all criminal matters arising within their counties where the nanishments cannot exceed a fine of fifty dollars, or imprisonment for one month. When an insue of first shall be joined before a justice, on demand of either party thereto, he should cause a jury of six men to be summoned, who shall try the same. The party against whom judgment shall be refidered in any civil action, may appeal to the Superior Contr from the same, and if the judgment shall exceed twenty-five dollars, there may be a new trial of the whole matter in the appellate court, but if the judgment shall be for twenty-five dollars or less than the case shall be heard in the appellate court, only upon matters of law. In all cases of a criminal nature, the party against whom judgment is given may appeal to the Superior Court, where the matter shall be heard new. In all cases
