A pig with "only one tail" and that growing out several inches above the lower end of the back is one of the curiosities here now. It was imported here by a man from Elizabethtown, in Bladen county. The owner says he has a pig at his home which runs about on five legs.

The Expressor learns that W. R. Trout, formerly a Hotel keeper in Asheville, was found lying dead in the road on Nantahala Mountain, a few days ago. On examination, his neck was found to be broken, and his horse was found loose within a few steps of the dead body. It is supposed that he fell off his horse and was killed by accident.

The Salem Press says that a citizen of that town, while working in his garden on Saturday last, was stung on one of his fingers by what is known as a corn worm. He had soon begun to swell, which extended to his arm and body, causing terrible suffering and delirium. The great poison antidote—corn whiskey—was given to the bitten man in considerable quantities, which relieved him and effected a complete recovery.

For instance, the merchants of Monroe, who, in going here for their supply of goods, have heretofore gone by the way of Charlotte, now come in this direction, two or three having passed through this city a few days since.

The Greensboro Patriot says: The negroes have been holding a revival on the road between here and New Garden, and last night a female got excited, and went into a trance, "sin sick" as they call it. They carried her to a neighboring house to attend to her. The crowd packed the cabin so closely that an infant lying in bed unnoticed was smothered or crushed to death before it was discovered.

The Milton Chronicle, the author of big snake stories, three legged chicken stories and a like, has now found in Halifax county, Va., a fourteen year old negro boy blind as a bat and promises to be a rival court, and that the Secretary be instructed to forward a copy of them to the family of the deceased, and that copies be furnished for publication in the papers of the city of Raleigh and other papers of the State.

Addresses were delivered by Judge Henry and Gen. W. R. Cox, both of whom paid merited compliments to the eminent character of the deceased. In accordance with the resolution to that effect, the Judge ordered the proceedings to be spread upon the minutes of the court.

HORRIBLE MURDER.—His Excellency Governor Brogden received on the 28th ult. a letter from the Coroner of Halifax stating that, on the night of the 26th ult., George W. Daniel, a colored member elect to the General Assembly from that county, was shot and killed by Joseph R. Branch, without the least cause or provocation, as was proven before the Coroner at the inquest. The murder was committed within five hundred yards of Daniel's house.

It seems that Daniel was quietly walking along the main county road in company with his wife and three other persons when Branch rode up behind them at full speed and cried out, "Clear the way." Daniel and his friends turned around to see what was the matter, when Branch shot Daniel in the side with buckshot, from the effects of which he died in about an hour. The parties were within six steps of each other when the firing took place. After the commission of the deed Branch fled and at last accounts had not been arrested. At the time of the murder he was mounted on a dark bay horse, and it is thought that he has fled the State. We have seldom been called upon to chronicle a more dastardly act than this. If all reports be true (and there seems to be no doubt), the utmost efforts of all classes of our people should be put forth to capture the criminal. We are authorized to state that just as soon as the Sheriff shall report the case in accordance with the statute, certifying that the accused cannot be arrested by ordinary process, the Governor will issue his proclamation offering a reward. In the meantime we call upon all who respect the law to be on the alert for the felon.

THE DEBT OF THE CITY OF RALEIGH. To the Holders of Bonds and Scrip of the City of Raleigh.

Anxious to do something for the relief of the creditors of the city, and to share the debt that the interest will promptly pay, for several months the Board of City Commissioners have had the subject under consideration, and have enacted the following ordinance as the result of their labors.

Every tax payer is interested in the financial welfare of the city as much so as the Commissioners, and every one should give their hearty co-operation to any measure calculated to relieve the city from its present embarrassments, and place it upon a safe financial basis.

Wherefore we appeal to our citizens to come forward and aid us in carrying out the provisions of this ordinance, which has been passed in good faith and with a sincere hope that it will meet the views of the public generally.

AN ORDINANCE FOR THE FUNDING OF THE CITY SCRIP, AND FOR OTHER PURPOSES.

WHEREAS, Prudence and economy, as also a due regard for the interest of the creditors of the city and the protection of its future credit, urgently demand that the amount of the funded and present unfunded or scrip debt, should be accurately ascertained, and some plan devised for the ultimate payment of the same:

And whereas, It is the desire and intention of the Board, by a rigid system of economy, to reduce to the smallest practicable amount, consonant with a safe and faithful administration of the city government, and to apply every cent not necessary to defray those expenses in payment of the indebtedness of the city; and so far as in the power of the Board, it is their intention to restrict the issue of scrip to the smallest amount, and to discount the same as soon as possible so as to protect from loss the honest employees of the city. Now, therefore,

Sec. 1. Be it ordained, That there shall be prepared under the supervision of the Mayor and Treasurer, bonds of the City of Raleigh, of the denominations of \$50, \$100, and \$500, bearing interest at the rate of eight per centum per annum, payable semi-annually, and of an amount sufficient to meet the requirements of this ordinance; and such bonds shall be under the Seal of the City of Raleigh, and countersigned by the Mayor and the Treasurer, and shall be issued as provided for in section three of this ordinance.

Sec. 2. Be it further ordained, That the bonds authorized by the foregoing section shall be dated on the 1st day of the month next succeeding their issue, one-fourth of which shall be payable one year after date, one-fourth two years after date, and one-half three years after date; and each and every holder of the scrip or warrants on the City Treasurer, or of bonds now due, or which may become due, when presented in amounts of \$50 and upwards, shall be entitled to exchange the same for the bonds authorized to be issued by this ordinance; and whenever presented in sums of a less amount than fifty dollars, the holder or holders thereof shall receive therefor a certificate of indebtedness, in such form as may be prescribed, bearing interest as the bonds above provided, dated in the same manner and of like tenor.

Sec. 3. Be it further ordained, That the Board of City Commissioners shall, upon the passage of this ordinance, cause to be well known to all freeholders of the city of Raleigh, whose duty it shall be to witness the Bonds and Certificates of Indebtedness, and to certify all Scrip, Bonds, and Certificates of Indebtedness, which may be presented for exchange; and no Bond or Certificate of Indebtedness shall be legal until so witnessed; and the Treasurer shall keep a book in which shall be recorded the date, number, amount, term, and to whom issued, of such Bond or Certificate of Indebtedness which may be issued by authority of this ordinance.

Sec. 4. Be it further ordained, That the coupons, or the interest due and accrued on said bonds and certificates of indebtedness, shall be received in payment of city taxes, and other indebtedness to the city, and when presented for that purpose, the said coupons shall be cut off and attached to the original coupons, and in case there are no coupons, such interest shall be credited on the bond or certificate, and the holder thereof shall give a receipt to the collector as his voucher for the payment of the same.

Sec. 5. Be it further ordained, That from and after the first day of October, A. D. 1874, no scrip or warrant upon the City Treasurer, shall be received in payment of city taxes, or other indebtedness thereof, unless for the taxes of those to whom the Scrip or Warrant was originally issued; but the same may be exchanged for the bonds or certificates of indebtedness authorized by this ordinance.

Sec. 6. Be it further ordained, That of the taxes annually collected, after the current year, there shall be set aside a sum sufficient to pay off the bonds that may become due during the year, and the same so set aside shall not be used for any other purpose until all the bonds and certificates of indebtedness so due shall have been paid off.

Sec. 7. Be it further ordained, That the Mayor and Treasurer are hereby authorized and empowered to issue bonds for a longer period than three years, upon the application of holders of bonds already issued, or of holders of City Scrip or Warrants on the City Treasurer, but all bonds so issued shall be under the same rates and regulations as the one, two and three years bonds authorized by this ordinance.

Sec. 8. Be it further ordained, That the City Treasurer shall, annually, before the taxes are levied, submit a report to the Board of Commissioners, of the amount of bonds, certificates of indebtedness and interest coming due during said year, and the Commissioners shall levy and collect a tax sufficient to pay off the same.

Sec. 9. Be it further ordained, That this ordinance shall be in force from and after its passage, 13, 1874.

Approved August 13, 1874. The Clerk was instructed to have this ordinance published in two of the city papers, and have 250 copies printed for public distribution.

Under section three of the above ordinance, Messrs. Alfred Williams and Jeff. Fisher were appointed to act with the Mayor and Treasurer. The bonds will be ready by the first of September, and due notice will be given when the committee will be ready to make the exchange.
