Speeches will be made at the following places: Creatan, on Tuesday, July 23; Gaskin's Mill Thursday, July 25; Adam's Creek Friday July 26; Swift Creek Saturday, July 27, and at Russell's Tuesday, July 30.

The Boat Race Yesterday.

Early yesterday afternoon all the wharves near Ferry Wharf were crowded with eager anxious citizens who had "turned out" to witness the boat race. The wind blew strong up the river and held good throughout the afternoon.

The course to be sailed, as per diagram, is about seven miles, but fully eight and a half miles were gone over by the boats which had to make many tacks,

The following boats were entered for the first race: Maggie, Thomas Jones, sailing master; Emma Katie, Guard Dixon, sailing master; Zula, B. O'Neal, sailing master; Leab, Wm. Salter, sailing master; Dread, Sheldon Lewis, sailing master.

Owing to an accident to the Rosalie, that boat did not sail.

The time made by the different boats, was as follows:

The Maggie started at 10 m. and 40 s. past 2 o'clock P. M. and returned at 29 m. and 3 s. past 4 o'clock, making the distance in 1 h. 38 m, and 53 s.

The Emma Katie started at 3 o'clock and returned at 28 m. and 24 s. past 4 o'clock making the distance in 1 h, 28 m. and 24 s.

The Zula started at 59 m. and 25 s. past 2 o'clock and returned at 31 m. and 21 s past 4 o'clock, having sailed the course in 1 h., 31 m. and 56.

The Leah started at 35 s. past 3 o'clock and returned at 39 m. and 55 s. past 4 o'clock, having sailed the course in 1 h., 39 m, and 20 s.

The Dread started at 54 s. past 3 o'clock and returned at 41 m. and 34 s. past 4 o'clock, having sailed the course in 1 h., 10 m. and 40 s.

The Judges then decided that the Emma Katie had won the race.

As the championship was to be awarded to the boat that beat two out of three races, and as there was sufficient time to sail another race before night, the boats were ordered to get ready for the second race.

The Rosalie and Sophie having made repairs entered the second race; the owners of the Dread declining to enter that boat

The Maggie started 40 m. and 8 s. past o'clock, P. M:, and returned at 26 m. and 9 s. past 6 o'clock, having sailed the course on the second race in 1 h. 37 m. and 1 s.

The Emma Katie started 52 m. and 2 s. past 4 o'clock, and returned 17 m. and 38 s. past 6 o'clock, having sailed the course in the second race in 1 h., 25 m. and 36 s.

The Zula started 51 m. and 31 s. past 4 o'clock and returned 18 m. and 51 s. past 6 o'clock, having sailed the course in the second race in 1 h., 27 m. and 20 s.

The Sophie started 49 m. 23 s. past 4 o'clock, and returned 21 m. and 7 s. past 6 o'clock, having sailed the course on the second race in 1 h. 31 m. and 44 f.

The Rosalie started 48 m. and 37 s. past 4 o'clock, and returned 30 m. and 5 s. past 6 o'clock, having sailed the course on second race in 1 h. 41 m. and 28 s.

The Emma Katie was then declared winner of the second race, and Was awarded the championship.

A time allowance of 30 seconds to the foot, measurment on the water line, on the entire course, was given, and the following is the measurement;

Rosalie, 14 feet 4 inches; Maggie, 15 feet: Sophie, 16 feet 10 inches; Emma Katie, 17 feet 6 inches; Zuls, 17 feet 6 inches; Leab, 23 feet.

Thus it will be seen that the Emma Katie beat the Zula, which was the next fastest boat in both races, 3 minutes and 32 seconds on the first race, and 1 minute and 44 seconds on the second race.

Proposals for Construction of Life Saving Stations.

Sealed proposals will be received at this office until 12 o'clock, noon, of Wednesday July 31, 1878, for the construction of thirteen complete life-saving stations, on the coasts of Virginia and North Carolina, ten of said stations to be erected at intermediate points between existing stations and three between Little Kinnakeet, North Carolina, and Hatteras Inlet. The seven Northern and six Southern stations will be bid for separately, and both contracts will not be awarded to the same party.

The buildings must be completed, ready for occupancy, on, or before the 15th day of November, 1878.

Each bid must be accompanied by a bond in the sum of \$1,000, with two good and sufficient sureties, conditional that the bidder will enter into contract without delay, if his bid be accepted.

All proposals must be endorsed "Proposals for the construction of seven lifesaving stations on the coasts of Virginia and North Carolina," or "Proposals for the construction of six life-saving stations on the coast of North Carolina," as the case may be, and addressed to the General Superintendent, U. S. Life-Saving Service, Treasury Department, Washington, D. C.
