The next Congress will be called on to make a new appointment of members. The number in the present House is 293. It is possible that this number may be increased to 309, but if no increase be made, the five Eastern States will have 21, the four Middle States 62, the fifteen Southern States 108, the nine Western States 91, and the four Pacific States 8. New England loses 1, the Middle States 6, the South gains 3, the Western States 6, and California 1. In the South, South Carolina gains 1, and Alabama loses 1. Texas gains 3; the other Southern States retain their present number. The basis of the apportionment would be 170,000 persons to one member; now it is 131,425.—News and Observer.

Chapel Hill needs one. Every well-regulated town should have one. If the commissioners who are in office now won't build one, let one of the issues in the election next May be whether a guard house shall be built in Chapel Hill or not. It is a disgrace to any civilized community to have grown men going up and down the streets like hyenas. Let a guard house be built and thus give protection to the law-abiding people of the town, by confining men who get drunk and create disturbances to the disgust of the respectable portion of the community.

Last Sunday the quiet little village of Chapel Hill was thrown into an unusual state of excitement by a report that Baxter King, a white man living a few miles from town had been killed. Late in the afternoon three men came dashing into town to procure a warrant for the supposed murderer. From them we learned that King and a man employed by him named Stuart had been fighting, which resulted in King's receiving several dangerous cuts on the head and face. At that time it was said that King would certainly die, but through the skillful management of Dr. George W. Purefoy his condition is now considered favorable. King and Stuart were both powerful men, each about 6 feet high, and said to be two of the best men, physically, in the county. Stuart has not been captured.

The funeral of Miss Ann J. Monroe, notice of whose death appears elsewhere in this paper, took place from the Episcopal Church in Chapel Hill, Sunday morning, Oct. 31st, at 11 o'clock, Rev. J. B. Cheshire conducting the services. The following named gentlemen acted as pall-bearers: Messrs. A. Mickle, John W. Carr, John H. Watson, George T. Winston, Luther J. Weaver and James C. Taylor. The deceased was beloved by the whole community. Rev. Mr. Heitman, of the Methodist church, suspended services at his church in order to give his congregation an opportunity to attend the funeral. The good people of Chapel Hill were very attentive to her in her illness, and though she has passed away she left friends behind who will ever hold in grateful remembrance the many kind acts of a noble, generous people. HORRIBLE DEED OF BLOOD IN OHIO. BATESVILLE, NOV. 8.—A horrible tragedy became known here yesterday morning. Frank M. Bledsoe, a wealthy young German, who, three years ago, married the daughter of a neighboring farmer, came home late Saturday night intoxicated, and entered the room where his wife and child were sleeping, assaulted them with an axe. His wife's skull was crushed by a single blow, and then he cut his son's throat on the edge of the axe. He then went to a room where Mrs. Stephens was sleeping, and killed Mrs. Stephens and her child. The servant girl was awakened, and sprang toward the door, but was knocked senseless and left for dead. Upon recovering consciousness she gave an alarm, and the neighbors came to the house. It was not till morning that the murderer was found in a tobacco house with his throat cut. He is not fatally injured. Jealousy, drunkenness and insanity are supposed to have led to the commission of the horrible crime.
