The amendment of Mr. Mebaue to strike out the \$50,000, and leave the amount blank was then lost.

The amendment of Mr. Richardson to strike out all of sections 8 and 9. (Section 8 prevents the scal ng of the State stock, and section 9, allows the Treasurer to take the bonds.) was then lost by a vote of 46 to 38.

Mr. Clarke moved to amend by saving that there shall be two sections of road, that only \$75,000 of bonds be issued, on the 50 miles already completed, and the Treasurer to take \$50, 0 0 of these only. Los'.

Mr. Mebane then offered an amendment that said road go to or near Cedar Falls Factory, Raudolph county. Lost. Mr. Turner offered an amendment that no ring man shall be appointed a director, but the House sat down it, as it also did on sundry other amendments of his, one of which was to not allow the consolidation with the Mt. Airy R. R. Co.

The bill then came up on its final reading, when it passed by a vote of 53 to 34.

Mr. Jones moved to reconsider the vote by which the bill passed and to lay that motion on the table. Adopted.

Messages from the Senate transmitting, various blls were sent in and the bills referred to the proper committees. Leave of absence was granted Mr. Hines for Monday, Mr. Hewitt for one week, for Mr. York for to-day.

At 2 p m the House adjourned until Monday.

A Horrible Outrage.
