

"That the said Commissioners elected by this General Assembly, and their honest people who try to imitate and successors in office, shall be and they counterfeit it. have a common seal. The term of office of said Commissioners shall begin immediately after their election by this General Assembly and their qualification, and shall continue until the first day of January, nineteen hundred and one, and their successors are elected and quilified.

At the election for State officers in nineteen hundred, there shall be elected three Commissioners by the qualified electors of this State at the time and places of voting for the members of the Legislature, one of whom shall be elected for the term of two years, and on for the term of four years, and one for the term of six years. After the first election such Commissioners shall elected by the qualified electors of this State, at the time and places of voting for members of the Legislature for a term of six years, and shall be members of and constitute the North Carolina Corporation Commission.
