

Dr R. K. Gregory of Greensboro has Applied for Letters Petent for Three.

(Special to News and Observer.)

Greensboro, N. C., Nov. 1 .- Patent atorneys at Washington, D. C., have been sending notices to the inventors of the country that a keyless lock was very much needed by the government mail ser-

vice as well as by the public, and that such an invention would be sure to make a fortune for the inventor; that the American patent could be easily sold for \$50,000, and that the same patented in European countries would be equally valuable there.

Dr. R. K. Gregory, of this city, has applied for letters patent on three keyless locks.

These three locks are automatic combination locks. The combination in each one can be changed in a moment, and more than a thousand changes can be made in each one. The machinery in them is very simple and substantial and only consist of three pieces inside of the lock case. This case is stamped up like

a watch case, about the same size of an ordinary watch and in fact resembles a watch very much.


