# A YET DARKER CRIME

Mother and Daughter Outraged and Murdered and Three Sons of the Poor Woman Slain by Bludgeon and Blade. The Country , Aroused.

(By the Associated Press.) Eona, Tex., Sept. 28 .- Mrs. Conditt and four children, a daughter of thirteen and three boys from 6 to 10 years old, were murdered in cold blood at their home near here today. The mother and daughter were as-

saulted and their bodies brutally disfigured

A baby about two years old was the only one left alive. All of them seemed to have been murdered with some blunt instrument; their heads were crushed and their throats cut with a knife or razor. The girl and mother were killed in the house; the boys were killed about one hundred yards away.

Mr. Conditt was away working in the rice fields. A negro boy about twelve years old, was plowing in a field near the house at the time of the killing and heard the children screaming; he saw a man running af-ter a woman, who was running around the house. Being afraid to go to the house, he ran to a neighbor-ing house and told what he had

The person informed ran to the place and found the five members of the family killed. Officers were at once informed and the entire neighborhood is out in posses in search of the murderers. It is supposed there were two of them. Dogs have been sent for.
