A Woman Killed and Two Persons Likely to Die as Result of **Murderous** Attacks

LONG ISLAND ON A "TARE"


(By the Associated Press.) Riverhead, L. I., Sept. 15 .- A wo man was killed and two other persons are likely to die as the result of murderous attacks in two neighboring localities in eastern Long Island today. With throat gashed from ear to ear the body of Mrs. James Jones, 40 years old, was found in her home here. Beside her lay her husband living, but bleeding from a slight gash in his own throat. Jones, in a statement to the police, said he heard cries from the house, and rushing in found his wife murdered. In his despair he slashed his throat with a razor, he said. He accused two young negroes of doing the killing. The police, however, are

holding him in custody. Charged with seriously stabbing his wife with a chisel and fatally injuring Otto Schroeder, of Soathampton, with the same weapon, James E. Kalander, of Fort Lee, N. J., was brought here today from Southampton and lodged in the county jail. Kalander's wife and children were ivsiting at the Schroeder home. Kalander unexpectodly appeared before daylight and charged, finding his wife and Schroeder together, savagely attacked them both (with a carpenter's chisel, Schroeder receiving several thrusts in the abdomen. Neighbors intervened while Kalander, it is said, was holding his wife by the hair and thrusting at her with the weapon. She may die.


