

Pedro Lascurain took the oath as president ad interem in his capacity as minister of foreign affairs. The naming of Senor Lascurain by Con-gress at a prolonged session, beginning about 6 o'clock, was merely incidential and was fol-towed soon by the section of General Huerta to the presi-dency.

HOUSE REFUSES TO OVER-RIDE VETO

Lack of Five Votes Defeats Immigration Bill

Two Representatives Delay Action by Demanding That Bill Be Read by Clerk

(By the Associated Press.) Washington, D. C., Feb. 19 .- The House today refused, by a vote of 213 to 114, to pass the Dillingham-Burnett immigration bill over the president's veto. Five votes changed from the negative to the affirmative would have given the two-thirds necessary to override the veto.

Opposition to the measure was renewed as soon as Representative Burnett, of Alabama, chairman of the immigration committee, moved that the bill be reconsidered and passed over the president's veto. Representatives Goldfogle, of New York, and Curley, of Massachusetts, delayed action for about two hours




