All fourth-class postmasterships, ex. cept those paying less than \$180 a year, were thrown open to competitive examination by an order issued by President Wilson at Washington. These positions are retained in the classified service, but about 50,000 incumbents who were "covered" into the classified service by executive orders of previous administrations, will have to meet all comers in competitive examinations to hold their positions with civil service protection.
