It is extensively known that my brother lived and died in Texas, and that he was the author of several published works; and lest it should be supposed that Gen. Houston intended to include him in his general denunciation, is the cause why I ask you and the Editors of the Standard and Star to publish his let-ter. While I do not for a moment believe that Gen. Houston intended to reflect in the least, disrespectfully on the character of one towards whom he has so nobly expressed himself, still justice to that reputation so near and dear to me induces to the action of vindicating it, in the most authentic and public manner, from all suspicion.
