The Charlotte Democrat states that Dr. Charles Harris, a highly respectable citizen of Catawba county, came to his death on Monday night the 10th inst., under most distressing circumstances. It appears that be left home for the purpose of going to Cencord; but before proceeding directly for that point he had occarion to visit a neighbor' house, and in attempting to do so, he lost his way in the woods. On arriving at a small branch he dismounted from his horse in order to discover the road, and in crossing the branch he stepped upon the ice which yielded under his weight and plunged him in the water. EDITOR :- In giving an account of the proceedings of the House of Commons, in the evening session of Monday lust, on the bill to repeal the 12th section of the chapter in the Revised Code concerning "evidence." you say, "this bill repea's an act of '52 ad. nitting copies of will without probate, filed in the Secretary's office, as e-idence in Court."

This is an entire mistake. All will's were proved before the year 1778, either before he Courts or before the Governor. And all such as were proved before the Courts were removed, for granting there'n letters festamentary by the Governor, and safe keeping, into the office of the Secretary of State. -There are in that office, nearly filed a way and preserved in cloth envelopes, thousands of wills, bearing date through a current period of nearly one hundred years. No lawyer, of understanding, who will thoroughly investigate the question, can doubt, as it seems to me, that every will filed away was duly prov-

It must be pretty clear that none of those which were presented for probate before the Courts, if they were not duly proven, would ever have been transmit ed for sufe keeping to the office of the Secretary of State. And t is reasonable to presume, that su h as were presented for prohate before the Governor and rejected, would not have been placed with those duly proved and filed away as records of the office.

LETTER FROM THE EDITOR. PETERSBURG, Jan. 20, 1857.

Instend of being a Raleigh to-night at "my sin hoose at hame," here am I. snowbound and frost-stricken, and with doubtful prospects of so n being released. 
