LANDING OF WILLIAM PENN.

The 143d anniversary of this event was celebrated at Philadelphia on Monday 24th ult. Among the guests were the President of the United States, Judge Washington of the Supreme Court, and the Duke Bernard of Saxe Weimar.

On the health of the President being given by the venerable Judge Peters, his Excellency rose and said, that he felt deeply sensible of the kindness and respect shown him by the toast just given, rendered as it was doubly dear to him by the revolutionary lips from which it proceeded. He felt, he said, sufficiently impressed with the importance of the event which had been commemorated on this day, with the elevated character of the distinguished founder of Pennsylvania, and the happy consequences which had flowed from the principles of his government. He would not trespass on the time of the company, by dilating upon the topics which had already been touched by a master's hand, in the discourse delivered in the morning; he could add nothing but his hearty concurrence in the sentiments expressed in that discourse. Repeating, therefore, his thanks for the kind reception given him, he proposed the following toast:

The landing of Wm. Penn. and "his great Town," the City of Brotherly Love.

3. Our distinguished & enlightened guest, the Duke Bernard of Saxe Weimar, in whom the virtues of the German population of Pennsylvania are finely illustrated.

The Duke of Saxe Weimar asked permission to return thanks in French, as being most familiar to him.

We subjoin a translation of this striking and eloquent speech.

Gentlemen—I consider myself particularly fortunate in arriving here at this moment when the descendants of those philanthropic men who first opened the wilderness, in this now hospitable country, celebrate the anniversary of their advent. That landing was one of the most remarkable events of modern history, since the most happy people in the Universe owe to it their existence. But it still becomes me, a stranger, to attempt to unfold before you the picture of your happiness, which fixes upon you the eyes of the whole civilized world, and draws among you foreigners eager to investigate the true sources of public happiness. It is in this point of view especially, and with the utmost pleasure, that I unite with you in celebrating a festival which ought to be that of all mankind.

A stranger in this country, the kind manner in which you have received me does me infinite honor, and gives me a satisfaction I cannot express. There is a sympathy of opinions which causes the distance that separates our birth places to disappear, and brings us nearer to each other, and carries the illusion so far as to make us believe that we are but one family. This is sympathy, which we feel in common with the wise and good of every country, & constitutes my peculiar happiness, tho' it makes me regret that circumstances do not enable me to fix my residence permanently among you.

I carry with me, deeply impressed upon my heart, the remembrance of the affectionate welcome you have given me. The festival we celebrate this day can never be effaced from my memory; and the presence of the first magistrate of the people—the people I repeat—the happiest people on the face of the earth—adds still brighter tints to the picture. Be assured, Gentlemen, of the grateful sentiments I cherish towards you, and allow me to carry across the Ocean the impression, perhaps too flattering to me, that I leave behind me some friends in whose memory I shall continue to be present.

AGRICULTURAL.

At the late Annual Meeting of the Pennsylvania Agricultural Society held at Prospect Hill, in Philadelphia county, almost every one of the premiums for neat Cattle were taken by JOHN HARE

POWELL, Esq. who relinquished the whole of them, amounting in value to \$295, for the benefit of the Society.

This public-spirited gentleman has taken a deep interest in the improvement of the breed of Cattle, and has spared no pains to procure and introduce the most approved descriptions. Of his success the above affords sufficient evidence especially when it is known that there were upwards of a hundred head of cattle presented for competition. Every animal that obtained a premium, whether belonging to Mr. POWELL or not, was of the breed of Improved Durham Short Horns, from Mr. POWELL'S Stock. These premiums were awarded by disinterested practical Farmers of high standing, and may be considered as a reward of merit. To Mr. POWELL also, was awarded several premiums for Sheep, of the Dishley, Southdown & Tunisian breeds. JONATHAN ROBERTS, formerly a Senator of the United States, is President of this Society, and Dr. Wm. DARRINGTON, formerly a Representative in Congress, delivered the Annual Address before it.

Agriculture in Virginia.—The premium offered by the Agricultural Society of the Shenandoah Valley of Virginia, for the best conducted farm, was awarded to H. S. Turner, Esq. of Jefferson county, upon which the Editor of the American remarks: "Rich land is a very good thing, but talents and discernment only can make the most of it. They tell in agriculture as well in other affairs."

PUNISHMENT OF SCHOLARS.

An action was lately tried before the Supreme Court of New-Hampshire, at Guilford, for an alleged assault and battery. The plaintiff was a boy of ten or eleven years old, and the defendant an instructor in a school, of which Plaintiff was a scholar. For some misdemeanor, the plaintiff had been chastised by the defendant during school hours; and at the close of the school for the day, the scholars not having dispersed, the plaintiff asked the defendant why he whipped him more than the other boys? the defendant replied that he did not whip him more than other boys who transgressed the rules of the school in an equal degree. The boy then told the instructor he was a *Good-d-d liar*, and ran out of the house; the instructor followed, caught him, and whipped him back to the house, for which the plaintiff brought this suit. It further appeared, that the plaintiff was soundly flogged, and that stripes remained on his back for ten days afterwards. The chief justice charged the jury very clearly on the subject, the jury retired for a few moments, and returned a verdict, (as every sound minded man would have done,) of *not guilty*. The law laid down in this case was, that instructors have full right to punish their pupils for the transgression of the rules of the rules of their schools, even though the school may have been dismissed; if the scholar so transgressing, has not gone home to his parents or master.—*Boston Courier*.
